SERVICE AREA AGREEMENT
COF Contract 2019-0292

This Service Area Agreement (“Agreement”) is entered into by and between Milcrofton Utility District of Williamson County, Tennessee (“Milmcrofton”), and the City of Franklin, Tennessee (“Franklin”).

Whereas, Milcrofton is a utility district created under the Utility District Law of 1937, Tenn. Code Ann. § 7-82-101, *et seq.*;

Whereas, Milcrofton has the exclusive right to provide water service within its boundaries under 7 U.S.C. § 1926(b) and Tenn. Code Ann. § 7-82-301(a)(1)(B) but can also provide water service outside its boundaries under Tenn. Code Ann. §§ 7-82-302(a)(1) and -304(a)(3);

Whereas, Franklin is a municipal corporation established and governed by private acts of the Tennessee General Assembly;

Whereas, Franklin has its own water distribution system;

Whereas, Milcrofton and Franklin share a common boundary;

Whereas, the parties have discovered that, for several years, Franklin has been providing water service to certain parcels that lie partially or wholly within Milcrofton’s boundaries and vice versa;

Whereas, the parties wish to clarify and settle their respective rights and obligations to provide water service along their common boundary;

Whereas, Tenn. Code Ann. § 12-9-108 authorizes any public agency to contract with another public agency to perform any governmental service, activity, or undertaking, including the provision of utility service, that each public agency is authorized by law to perform;

Whereas, Tenn. Code Ann. § 7-82-304(a)(11) authorizes a utility district to exercise any of its powers under the Utility District Law of 1937 jointly with another municipality and to contract

with the other municipality for that purpose;

Whereas, at a public meeting on _____, 2019, which was previously advertised to the public in accordance with law, Milcrofton's Board of Commissioners approved this Agreement and authorized its president to execute this Agreement on behalf of Milcrofton; and

Whereas, at a public meeting on _____, 2019, which was previously advertised to the public in accordance with law, Franklin's Board of Mayor and Aldermen approved this Agreement and authorized the mayor to execute this Agreement on behalf of Franklin;

Now, Therefore, for and in consideration of the mutual covenants of the parties and other good and valuable consideration, the receipt and legal sufficiency of which are hereby acknowledged, the parties do hereby agree as follows:

1. To identify the parcels at issue in this Agreement, a map consisting of two pages (“the Map”) is attached hereto as Exhibit A and incorporated herein by reference. On the Map, parcels are shaded in blue for “Milkrofton Utility District,” yellow for “Current COF, MUD upon redevelopment,” and red for “City of Franklin.” The purpose of the Map is to show the subject matter of this Agreement. The Map does not purport to show Milkrofton’s boundaries, as set forth in its October 10, 1975, order of recreation from the County Court of Williamson County, Tennessee. The Map does show areas where Milkrofton and Franklin will provide water service henceforth pursuant to this Agreement.

2. To further aid in the identification of such parcels, spreadsheets listing parcels by color and providing information about them (“the Spreadsheets”) are attached hereto as Exhibit B. Because the Spreadsheets may not be perfectly up-to-date and accurate by the time this Agreement is executed, in the event of any conflict between the Map and the Spreadsheets, the Map will

control.

3. Milcrofton has the exclusive right to provide water service to the parcels shaded in blue on the Map. Milcrofton assumes all duties, liabilities, and obligations to provide water service to the blue parcels. Milcrofton will provide water service to the blue parcels in accordance with Milcrofton's rules, regulations, and policies. All fees and charges paid by developers or customers for water service provided by Milcrofton to the blue parcels will belong to Milcrofton. Notwithstanding the foregoing, Franklin agrees to provide water service sufficient in volume and pressure to support a fire suppression system to the parcel in blue designated as Map 117, Parcel 26, 4404 Peytonsville Road, until Milcrofton can make fire protection available to that parcel.

4. Franklin has the exclusive right to provide water service to the parcels shaded in red on the Map. Franklin assumes all duties, liabilities, and obligations to provide water service to the red parcels. Franklin will provide water service to the red parcels in accordance with Franklin's rules, regulations, and policies. All fees and charges paid by developers or customers for water service to the red parcels will belong to Franklin.

5. The Map shows several parcels shaded in yellow, described as "Current COF, MUD upon redevelopment" in the Map's legend. Franklin currently provides water service to the yellow parcels. For each of these yellow parcels, Franklin will continue to provide water service until one of the following occurs: (a) Milcrofton has the infrastructure in place to provide water service to such parcel and elects to do so, or (b) a building permit is requested for such parcel and Milcrofton elects to provide water service, as described below.

If a building permit is requested for any type of work on a yellow parcel, then Franklin, prior to issuing a building permit, will inform the property owner to contact Milcrofton about water service. Milcrofton will have discretion either to provide water service to the parcel or to defer providing water service. If Milcrofton defers providing water service, then the same process will

be followed any time a future building permit is requested for any type of work on such parcel, until Milcrofton elects to provide water service.

Once Milcrofton elects to provide water service to a yellow parcel under this Section 5, Milcrofton will have the exclusive right to provide water service to such parcel thereafter and will assume all duties, liabilities, and obligations to provide water service to such parcel. Milcrofton will provide water service to such parcel in accordance with Milcrofton's rules, regulations, and policies. After Milcrofton elects to provide water service to a yellow parcel under this Section 5, all fees and charges paid by developers or customers for water service to such parcel will belong to Milcrofton.

Upon execution of this Agreement, Milcrofton will notify the property owners of the parcels in yellow, by certified mail, of this Agreement and the procedures the property owners must follow to request water service from Milcrofton.

6. Should any parcel(s) on the Map be subdivided, merged, or renumbered, it will not affect the parties' respective rights and obligations under this Agreement with respect to the areas depicted on the Map.

7. The existing boundaries of both Milcrofton and Franklin will remain unchanged.

8. This Agreement constitutes the entire agreement of the parties. This Agreement may be modified or amended only by an instrument in writing executed by the parties.

9. No third party obtains any benefits or rights to water service under this Agreement, and this Agreement is not assignable to or for the benefit of any other person or entity without the mutual written agreement of the parties.

10. The invalidity or unenforceability of any provision of this Agreement will not affect the validity or enforceability of the remaining provisions.

11. This Agreement is governed by the laws of Tennessee without regard to choice of

law principles, and any dispute or legal action arising out of or related to this Agreement must be filed in the courts of Williamson County, Tennessee.

12. The parties have participated jointly in the negotiation and drafting of this Agreement. This Agreement will not be construed for or against either party based upon authorship.

13. The individuals signing below represent that they have full authority to execute this Agreement on behalf of their respective parties; that this Agreement has received any approval required by law from their respective parties; and that this Agreement is legal, valid, and binding.

14. This Agreement will become effective when all of the following have occurred: (1) the President of Milcrofton signs below, (2) the Mayor of Franklin signs below, and (3) a representative of the United States Department of Agriculture, Rural Development, approves this Agreement by signing below.

15. This Agreement may be signed in counterparts. Copies of signatures to this Agreement delivered via facsimile or via e-mail in Adobe portable document format (.pdf) shall be deemed originals.


