

RESOLUTION 2015-17

A RESOLUTION AWARDING THE CONSTRUCTION CONTRACT (COF CONTRACT NO 2014-0272) TO LAYNE INLINER IN THE AMOUNT OF \$1,411,950.00 FOR THE ANNUAL ON-CALL SANITARY SEWER AND MANHOLE REHABILITATION PROJECT

WHEREAS, the Annual On-Call Sanitary Sewer and Manhole Rehabilitation Project is a project identified by the City of Franklin to facilitate ongoing renewal of infrastructure; and

WHEREAS, the construction of the Annual On-Call Sanitary Sewer and Manhole Rehabilitation Project generally includes the labor, materials and equipment necessary for sanitary sewer and manhole rehabilitation to be constructed under the General Requirements and Technical Specifications for the Water Management Department; and

WHEREAS, on January 22, 2015, sealed bids were received in the office of the City Engineer, City Hall, 109 3rd Avenue South, Franklin, Tennessee 37065 and were publicly opened and read aloud for the Annual On-Call Sanitary Sewer and Manhole Rehabilitation Project (COF Contract No. 2014-0272); and

WHEREAS, City Staff recommends awarding the construction contract (COF Contract No. 2014-0272) to Layne Inliner, who is the low bidder based on the unit amounts provided in the bid documents for a comparison competitive bid process at a cost of One Million Four Hundred Eleven Thousand Nine Hundred Fifty and No/100 Dollars (\$1,411,950.00); and

WHEREAS, the annual funding amount to be authorized for expenditure in association with COF Contract No. 2014-0272 shall be approved by the Board of Mayor and Aldermen as part of the Water Management Department's Annual Budget; and

WHEREAS, contract unit prices shall be for a one-year period starting July 1, 2015 (FY 2016), at which time the City of Franklin may elect to extend the contract for a one-year period provided Layne Inliner agrees to the extension; and

WHEREAS, the contract unit prices may be extended for a third year upon approval by the City of Franklin Board of Mayor and Aldermen provided Layne Inliner agrees to the extension.

NOW THEREFORE, BE IT RESOLVED by the Board of Mayor and Aldermen of the City of Franklin, Tennessee, that approval is granted for the bid award to Layne Inliner for the Annual On-Call Sanitary Sewer and Manhole Rehabilitation Project (COF Contract No. 2014-0272) in the amount of One Million Four Hundred Eleven Thousand Nine Hundred Fifty and No/100 Dollars (\$1,411,950.00).

BE IT FURTHER RESOLVED BY THE BOARD OF MAYOR AND ALDERMEN OF THE CITY OF FRANKLIN, TENNESSEE that the City Engineer or the Director of Water Management Department is hereby authorized to review and approve the spending of all project funds included in the bid and to award the construction contract for the Annual On-Call Sanitary Sewer and Manhole Rehabilitation Project (COF Contract No. 2014-0272).
