

ORDINANCE 2016-17

TO BE ENTITLED: “AN ORDINANCE TO TEMPORARILY REDUCE THE SPEED LIMIT ON HILLSBORO ROAD (SR-106) FROM DEL RIO PIKE TO MACK HATCHER PARKWAY TO TWENTY FIVE MILES PER HOUR (25 MPH) IN BOTH DIRECTIONS FOR THE DURATION OF THE HILLSBORO ROAD IMPROVEMENTS PHASE 2 CONSTRUCTION PROJECT.”

WHEREAS, Hillsboro Road (State Route 106) is classified as a Major Arterial within the City’s Major Thoroughfare Plan; and

WHEREAS, the current speed limit of Hillsboro Road is Thirty-Five Miles Per Hour (35 MPH) between Del Rio Pike and Mack Hatcher Parkway; and

WHEREAS, the construction zone required to complete the Hillsboro Road Improvements Phase 2 Project will stretch from Del Rio Pike to Mack Hatcher Parkway; and

WHEREAS, engineering principles and judgment related to vehicular driver and construction worker safety justify a temporary reduction in the speed limit from Thirty-Five Miles Per Hour (35 MPH) to Twenty-Five (25 MPH).

NOW THEREFORE:

SECTION I: BE IT ORDAINED by the Board of Mayor and Aldermen of the City of Franklin, Tennessee, that the speed limit on Hillsboro Road (SR-106), from Del Rio Pike to Mack Hatcher Parkway, be temporarily decreased to Twenty-Five Miles Per Hour (25 MPH) in both directions for the duration of construction of the Hillsboro Road Improvements Phase 2 Project.

SECTION II: BE IT FURTHER ORDAINED by the Board of Mayor and Aldermen of the City of Franklin, Tennessee, that the speed limit on Hillsboro Road (SR-106), from Del Rio Pike to Mack Hatcher Parkway, be returned to Thirty-Five Miles Per Hour (35 MPH) in both directions after the completion of construction of the Hillsboro Road Improvements Phase 2 Project.

SECTION III: BE IT FURTHER ORDAINED by the Board of Mayor and Aldermen of the City of Franklin, Tennessee, that the penalty for failure to obey the provisions of this Ordinance shall be as indicated in the Franklin Municipal Code and/or the Tennessee Code Annotated.

SECTION IV: BE IT FINALLY ORDAINED by the Board of Mayor and Aldermen of the City of Franklin, Tennessee, that this Ordinance shall take effect from and after its passage on second and final reading, the health, safety and welfare of the citizens of Franklin requiring it.
