## **ORDINANCE 2019-30**

## AN ORDINANCE TO ZONE 474 ACRES ESTATE RESIDENTIAL (ER) DISTRICT, FOR THE PROPERTY LOCATED SOUTH OF LONG LANE AND EAST OF INTERSTATE 65.

WHEREAS, several property owners, depicted below and on Exhibit B, ("Owner(s)") of property located south of Long Lane and east of Interstate 65, as listed below and on Exhibit A ("Property") petitioned the Board of Mayor and Aldermen (BOMA) of the City of Franklin, Tennessee ("City"), to annex Property adjoining the City limits and located within the Franklin Urban Growth Boundary (UGB); and

**WHEREAS,** the BOMA has adopted a Plan of Services as described in Resolution 2019-78, and annexed the property through referendum held on October 22, 2019; and

**WHEREAS,** the City of Franklin, Tennessee, encourages responsible growth and the sensible transition of land uses and densities; and

**WHEREAS**, the Estate Residential (ER) district, provides zoning for land uses compatible with both the existing use of the property and the surrounding development; and

**WHEREAS**, the appropriate Overlay Districts, Character Area Overlay District, and Development Standards will be assigned after the area can be studied by the Planning and Sustainability Department, and the land can be included in Envision Franklin; and

**WHEREAS,** the zoning has been reviewed and approved by BOMA after a public hearing and a recommendation by the Franklin Municipal Planning Commission (FMPC).

NOW THEREFORE, BE IT ORDAINED BY THE BOARD OF MAYOR AND ALDERMEN OF THE CITY OF FRANKLIN, TENNESSEE, AS FOLLOWS:

**SECTION I.** That the following described Property shall be, and is hereby, zoned Estate Residential (ER) District:


