

RESOLUTION 2019-112

A RESOLUTION TO AUTHORIZE STAFF TO ENTER INTO CONTRACT NEGOTIATIONS WITH SELECTED CONSULTING FIRMS FOR PROFESSIONAL DESIGN AND CONSULTING SERVICES FOR PARKS PROJECTS

WHEREAS, the City has identified, based on the priority of planning for future growth and development of the City, parks projects that may be undertaken during the first five (5) years following the date of this resolution; and

WHEREAS, the City issued a Request for Qualifications to identify eligible consultants to assist with future park projects in the following categories: General Planning / Design / Engineering, Architecture, Landscape Architecture, and Historic Preservation / Restoration; and

WHEREAS, the following consultants responded to the City's Request for Qualifications: Barge Design Solutions, Inc., Civil & Environmental Consultants, Inc., Collier Engineering Co., Inc., Gamble Design Collaborative, Genesis Engineering Group, LLC, HDLA, HFR Design, Inc., Integrous Architecture, Kimley-Horn, Kiser + Vogrin Design, Lose Design, Ross / Fowler, P.C., Sullivan Engineering, Inc., Thomas & Hutton Engineering Co., Tuck-Hinton Architecture & Design, and W&A Engineering; and

WHEREAS, the City has determined all firms to be eligible for selection based on the submitted responses to the Request for Qualifications.

NOW THEREFORE, BE IT RESOLVED by the Board of Mayor and Aldermen of the City of Franklin, Tennessee, that City staff shall be authorized during the first five (5) years following the date of this resolution to enter into contract negotiations with the following consulting firms for the General Planning / Design / Engineering category of anticipated work on a project-by-project basis giving consideration to the specific qualifications of each firm and the firm's capacity to perform the necessary work at the time of project letting: Barge Design Solutions, Inc., Civil & Environmental Consultants, Inc., Collier Engineering Co., Inc., Genesis Engineering Group, LLC, HFR Design, Inc., Integrous Architecture, Kimley-Horn, Kiser + Vogrin Design, Lose Design, Ross / Fowler, P.C., Sullivan Engineering, Inc., Thomas & Hutton Engineering Co., and W&A Engineering. This resolution does not entitle any consulting firm to any work with the City.

This resolution does not entitle any consulting firm to any work with the City.

BE IT FURTHER RESOLVED by the Board of Mayor and Aldermen that City staff shall be authorized during the first five (5) years following the date of this resolution to enter into contract negotiations with the following consulting firms for the Landscape Architecture category of anticipated work on a project-by-project basis giving consideration to the specific qualifications of each firm and the firm's capacity to perform the necessary work at the time of project letting: Barge Design Solutions, Inc., Civil & Environmental Consultants, Inc., Collier Engineering Co., Inc., Gamble Design Collaborative, HDLA, Kimley-Horn, Kiser + Vogrin Design, Lose Design, Ross / Fowler, P.C., Thomas & Hutton Engineering Co., and W&A Engineering. This resolution does not entitle any consulting firm to any work with the City.

BE IT FINALLY RESOLVED by the Board of Mayor and Aldermen that City staff shall be authorized during the first five (5) years following the date of this resolution to enter into contract negotiations with the following consulting firms for the Historic Preservation / Restoration category of anticipated work on a project-by-project basis giving consideration to the specific qualifications of each firm and the firm's capacity to perform the necessary work at the time of project letting: Civil & Environmental Consultants, Inc., Integrous Architecture, and Tuck-Hinton Architecture & Design. This resolution does not entitle any consulting firm to any work with the City.
