

**ORDINANCE NUMBER 2016-024**

**TO BE ENTITLED: "AN ORDINANCE TO AMEND THE CITY OF FRANKLIN MUNICIPAL CODE, APPENDIX A - COMPREHENSIVE FEES AND PENALTIES, CHAPTER 16 – STREETS & SIDEWALKS, ETC., FOR THE PURPOSE OF ADDING STREET OCCUPANCY AND VALET PARKING PERMIT FEES."**

**WHEREAS**, for the purpose of promoting the public health, safety, comfort, convenience, and general welfare of the people of Franklin, Tennessee the Board of Mayor and Aldermen is authorized to prescribe regulations and standards that encourage and advance the quality of life within the City; and

**WHEREAS**, the Board of Mayor and Aldermen found that ordinances and policies that regulate land use, guide the maintenance of the city's infrastructure, and delivery of essential services must be dynamic and modified from time to time to reflect changes in best practices, model codes, land and labor costs, and safety standards necessary to preserve and promote the private and public interest; and

**WHEREAS**, the Board of Mayor and Alderman has decided to create a separate title in the Franklin Municipal Code for the sole purpose of listing all the fees and penalties charged and assessed by the city, entitled Comprehensive Fees and Penalties.

**NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF MAYOR AND ALDERMAN OF FRANKLIN, TENNESSEE AS FOLLOWS:**

**SECTION I:** That Appendix A, Chapter 16 – Streets & Sidewalks, etc. of the Franklin Municipal Code be amended by inserting and codifying the following fees to read as follows. Additional text is highlighted in **bold**:

CHAPTER 16. - STREETS AND SIDEWALKS, ETC.

\* \* \*

<i>Excavation and Cuts within Public Right-of-Way</i>	
Permit fee to excavate in, or across streets, roads, alleys, sidewalks, or the public right-of-way.	\$100.00
Certificate of insurance	Liability insurance: For bodily injury shall not be less than \$200,000.00 for each person; and \$500,000.00 for each accident; and \$1,000,000.00 aggregate; and For property damages not less than \$500,000.00 for any one accident and a \$1,000,000.00 aggregate.

<b><i>Street Occupancy or Obstruction</i></b>	
Permit fee to occupy or obstruct public streets, alleys, sidewalks, or the public right-of-way for building operations.	\$25.00 for 24 hours, \$50.00 for up to 1 week (7 days), \$100.00 for up to 30 days, Renewable at \$100.00 per month or portion thereof.
Certificate of insurance	Liability insurance of \$250,000.00 per occurrence insuring the owner or operator against liability for personal injury in addition to additional up to \$1,000,000.00 per person and \$3,000,000.00 per occurrence; and \$1,000,000.00 single-limit coverage for bodily injury and property damage; and proof of applicable TN worker's compensation insurance.
Surety/ Bond	Minimum \$2500.00 or as determined by Street Department Director or his designee.
<i>House Moving</i>	
Permit fee	\$50.00
Certificate of insurance	Liability insurance for property damages not less than \$50,000.00

<b><i>Valet Parking</i></b>	
Permit Fee - Annual	\$10.00 per linear feet of the Valet Zone. Minimum \$250
Permit Fee – Special Event or Special Occasion (2-day max)	\$5 per linear feet of the Valet Zone. Minimum \$125
Certificate of Insurance	As determined by the City of Franklin Risk Manager

**SECTION II: BE IT FINALLY ORDAINED BY THE BOARD OF MAYOR AND ALDERMEN OF THE CITY OF FRANKLIN, TENNESSEE,** that this ordinance shall take effect from and after its passage on second and final reading, the health, safety and welfare of the citizens of Franklin, Tennessee requiring it.
