Motion to approve Ordinance 2016-40 approved on Third and Final Reading by a 7-1 vote, with Alderman Martin voting against.

Brad Baumgartner: Rezoning required because the applicant is proposing a Development Plan Revision which includes the commercial square footage on the site. Land Use Plan supports the changes. Staff recommends approval.

Alderman Barnhill moved to approve Ordinance 2016-46. Seconded by Alderman Petersen. Motion carried unanimously.

Alderman Ann Petersen, FMPC Representative Brad Baumgartner, Senior Planner Brad Baumgartner: Development Plan Revision to expand the commercial square footage for this site. The recent approval of the Family Legacy site plan to the south of this property renders the incompatible use buffer not applicable, and the applicant is planning to remove it. The commercial square footage is increasing by 7,520 square feet because removal of the buffer allows a larger developable area. Only Phase 3 is being adjusted with this revision.

Public Hearing

With no one coming forward to speak, Mayor Moore declared the Public Hearing closed

Alderman Barnhill moved to approve Resolution 2016-74. Seconded by Alderman Petersen.

There was a bit of confusion regarding Modification of Standards. Emily Hunter explained the Modifications of Standards were approved as part of Resolution 2014-97 in 2014, as shown on page three of this Resolution.

Alderman Burger asked how many feet between this and the next residential structure to the south, and is there proper buffering. Mr. Baumgartner responded the property to the south is Family Legacy and the buffer is there.

Motion to approve Resolution 2016-74 carried unanimously.
