AMENDMENT A

**TO THE MEMORANDUM OF UNDERSTANDING BETWEEN WILLIAMSON COUNTY, TENNESSEE
AND THE CITY OF FRANKLIN, TENNESSEE CONCERNING BREATHALYZER TESTS**

THIS AMENDMENT is made by and between WILLIAMSON COUNTY, TENNESSEE, a county governmental entity of the State of Tennessee ("County"), and the CITY OF FRANKLIN, TENNESSEE ("Franklin"), a municipal government located at 109 Third Avenue South, Franklin, Tennessee 37064, and is made a part of the original Memorandum of Understanding ("MOU") that was executed and filed in the office of the Williamson County Mayor. In the event of any conflict in language or in purpose between this Amendment and the MOU, exhibits, or any other previously executed addenda, this Amendment shall control.

WHEREAS, the MOU provides the parties the ability to extend the MOU by written agreement for additional terms of five (5) years each contingent on the parties legislative bodies appropriating the funds each fiscal year;

WHEREAS, the parties have agreed to exercise the ability to extend the MOU for an additional five (5) year term for the same material terms contained in the MOU; and

NOW, THEREFORE, THE PARTIES HEREBY AGREE AS FOLLOWS:

1. The current term of the MOU is scheduled to expire on June 30, 2018. The extended term shall begin on July 1, 2018 and terminate on June 30, 2023 unless otherwise terminated as provided for in the MOU. The extended term shall be continuous without any break in the term of the MOU. The MOU may be extended by written agreement of the parties for additional terms of five (5) years each for the same material terms dependent on the parties' legislative bodies funding the cost of the services for each fiscal year of the five (5) year term. Should either party's legislative body fail to fund the costs provided in the MOU, the MOU shall terminate on the last day of the current fiscal year in which funds were appropriated.
2. The County's Mayor and the chief administrating officer for Franklin shall be responsible for administrating the joint undertaking for their respective governments.
3. This Amendment shall not affect the remaining provisions of the MOU and all provisions not in conflict with this Amendment shall remain in effect.
