• ISO CLASS 1 Fire Protection Rating

Eric Stuckey recognized an important accomplishment by the Franklin Fire Department. The City received the top rating for fire protection services. Only 132 cities out of 48,754 rated in the U.S. have been awarded this classification. Congratulations to Chief Rocky Garzarek and his department.

The City sold the land that had been designated for Fire Station 7 in Berry Farms when it was determined that property on the southern portion of the AG Center on the east side of I-65 would be better. The amount of \$640,000 was realized from the sale.

Public Hearing

- Planning clarified BOMA will vote whether the applicant and staff continue to work on the draft plan of services and development plan for the current development named Ashcroft Ridge. Approval does not approve annexation.
- 4th District County Commissioner Gregg Lawrence, 4100 Clover Meadows, Franklin: His constituents asked that he speak to issues of concern regarding this annexation. He understands the vote is preliminary. All the communities surrounding this development will be in the County. Three main issues: 1) is there enough infrastructure to support a development surrounding unique property with no access to a major thoroughfare. Developments have tried to make an access to Highway 96, but cannot because of TDOT. 100% of traffic will go through these developments. If 250 houses are put on the property, it will destroy the aesthetics of the neighborhoods. A major concern. 2) They don't want traffic backups. They already have them on Highway 96, and as he understands it the majority come out on Ridgeway Road at 96 and will create more backups with the new volume. 3) Height requirements. Lots of height on the ridge with building on hillsides. There will have to be retaining walls, etc. He asked that the Board seriously consider these issues.
- Larry Cox, 220 Vantage Way, Franklin: He has seen a drastic change in Franklin over the last 30 years. Look at the quality of life today and look at what is trying to be done with this property. It will change the lives of many who have lived here for many years. Be careful and not change that. The image of Franklin – a great place to live. Don't change it.
- Susan Caplen, 1991 Beacon Hill Drive, Franklin: Safety of children, older generation, joggers, etc. in the neighborhood. In their neighborhood community and the communities in the surrounding area there are no sidewalks, there are narrow winding roads, people walking dogs, etc. This development would destroy that. Afraid the volume of traffic would harm children.
- Brian Caplen, 1991 Beacon Hill Drive, Franklin: Concerned with traffic issues, 20' roads. The hill in front of his house, Warren Road, narrow roads with no sidewalks. In the winter can't get down the hill. School buses another concern.
- Mark Moehle, 1115 Ridgeway Drive, Franklin: Traffic concerns and safety. Has lived at the corner of Ridgeway and Stanford for more than 18 years. It is a great community with very little traffic on the road. Everyone walks and talks to each other. The roads are currently safe. This project would generate excess traffic. People are out walking with strollers, etc. He wants future residents in their community to enjoy what his family has; skateboarding, bike riding, walking. Hopes the Board will consider their community and not vote in favor of this.
- Claudio Romeo, 4257 Warren Road, Franklin: The road they are planning to build is at least at a 45 degree angle. Very steep with a ravine at the end that is

10'-15' deep. This is a small and dangerous road. Cars cannot get around buses. Yards face down at least a 30 degree angle. His property line is 5' beyond the patio. Whatever they build will be that close to his house. Warren is dangerous with a lot of traffic getting to Arno Road. The beauty and quaintness will be lost.

- Jon Hood, 4264 Warren Road, Franklin: There are dead spots on Warren Road and he has to cross the road when walking every night to make sure he is seen by approaching cars. If that many cars were added there would be a pinch point getting on Arno and Cedarport Roads. His boys play in the street, it is a dead end. Not in favor of development.
- Tim Thompson, 4253 Warren Road, Franklin: On the map, where the road is proposed to be, it is just an easement, on the PowerPoints it shows a road, and it is not a road, it is a yard. Simmons Ridge also wants to connect into Warren Road and that would be 400 homes. He mentioned the lack of sidewalks, shoulder and the narrowness of the road. There is no traffic light at the Ridgeway exit. He asked the Board to look at the entire picture and not just this development and Simmons Ridge.
- Chris Hayes, 2002 Cedarport Drive, Franklin: Traffic concerns as well as light pollution and noise pollution. He can sit on the back porch and hear I-65 noise and see the light pollution from Carothers. He asked that the Board terminate this project to save resources and time.
- Al Gleason, 1157 Cross Creek Drive, Franklin: He lives next to the property in question. Look at the property developments all around and this pristine piece of property with wildlife, deer, turkey, bobcats, etc. Maybe another use could be a wildlife sanctuary or park. That opportunity is lost if the property is developed.
- Monique Kueker, 4245 Warren Road, Franklin: Has lived there a year and wanted the house for the reasons others have said. Public safety is the biggest problem. She has the most beautiful view in the area. Ms. Kueker quoted from the Land Use Plan and Ordinance about preservation and said it would be sad to destroy the view of that land with the wildlife.

With no one else coming forward to speak, Mayor Moore declared the Public Hearing Closed

Alderman Skinner moved to approve Resolution 2014-101. Seconded by Alderman Burger.

Discussion:

- Alderman Skinner said he heard a lot about traffic, yet he hasn't seen an official report or a traffic study. A traffic study should be done and evaluated to be fair to the applicant
- Alderman Martin related she felt pain when every subdivision came in, but now is delighted to have them. Most people would probably say they would like to have a park there, but it can't be done. That was left for future development by the owners. She added that most of Cedarport came and complained about traffic and wanted Carothers built to alleviate their traffic. Surely, these residents knew when they moved to Williamson County that it is one of the fastest growing counties.
- Alderman Bransford supports the motion to move it to the next discussion. There is concern about congestion on the roads.
- Alderman Burger wanted to move it forward to study it more thoroughly. The landowner has the right to sell and use the property how he chooses. Further study needed to bring back to the Board.
- Eric Stuckey noted there is need for an independent traffic study. There should be discussion with the County regarding roads, etc.

Alderman Skinner amended the motion to approve Resolution 2014-101 to include that the City select and order an Independent Traffic Study paid for by the Applicant. Seconded by Vice Mayor Barnhill.

Motion to amend carried unanimously 7-0. Main Motion as Amended carries unanimously 7-0.
