MISCELLANEOUS REPORTS

Eric Stuckey spoke about inclement weather expected Friday night and a Sunday rain date for the Christmas Tree Lighting. The annual Kiwanis Christmas Parade will take place Saturday.

Alderman Bransford moved to approve Consent Agenda Items 6-9 with Item 5 removed as requested by Alderman Martin. Seconded by Vice Mayor Barnhill. Motion carried unanimously.

NEW BUSINESS

 18-0103 Consideration of ORDINANCE 2018-35, An Ordinance to Amend TITLE 10 of the City of Franklin Municipal Code to Add a New Chapter 3, to Restrict the Sale of Dogs and Cats at Pet Stores.

[FIRST OF TWO READINGS]

Alderman Beverly Burger

Alderman Burger moved to approve Ordinance 2018-35. Seconded by Alderman McLendon.

Alderman Burger moved to amend to prohibit retail sale of Dogs and Cats except through rescue and rescue adoption days. Seconded by Alderman McLendon.

- Alderman Burger clarified she is a business owner and a promoter of small businesses.
 This ordinance will not affect any current businesses in Franklin. It will limit sales of any future cat and dog retail businesses. She read a prepared statement as well.
- Alderman McLendon advocated for the least restrictive solution, have the seller provide documentation of source which would verify the cats and dogs did not come from breeding mills. After thorough research he supports the ordinance and the amendment
- Alderman Speedy would like to see all puppy mills eradicated; however, he cannot
 support the ordinance because it all comes back to freedom of choice for the citizens of
 the community on where they want to buy their pets. One store has already closed
 taking away employees and removing a tax paying business. It is a dangerous
 precedent to have advocacy groups come in against a business even when the business
 is licensed and inspected by the state and the federal governments.
- Vice Mayor Barnhill: This restricts a business but does not abolish puppy mills. The emails he received were directed toward the business owner. This is a slippery slope. Government doesn't need to regulate or make a business illegal.
- Alderman Blanton: It is a public health situation. Her veterinarian has firsthand experience of animals sold at the local business that were ill and infected humans as well.
- Alderman Burger: The Ordinance will help eradicate puppy mills because Franklin will join 250 other cities with ordinances and others will follow.
- Shauna Billingsley: The Ordinance only addresses retail sale of dogs and cats in retail store fronts.

Motion to Amend Ordinance 2018-35 to prohibit retail sales of Dogs and Cats except through rescue and rescue adoption days carried 5-3 with Aldermen Bransford, Blanton, Martin, Burger and McLendon voting in favor, and Aldermen Petersen and Speedy and Vice Mayor Barnhill voting against the amendment.

Motion to approve Ordinance 2018-35, as amended, carried 5-3 with Aldermen Bransford, Blanton, Martin, Burger and McLendon voting in favor, and Aldermen Petersen and Speedy and Vice Mayor Barnhill voting against the ordinance. Ordinance 2018-35, as amended, approved on First of Two Readings.
