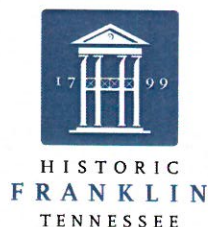

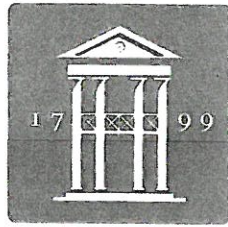

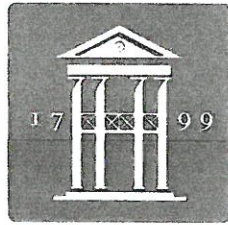

Hello Paul and Jonathan,

Thank you so much for your excellent presentation last week regarding streets, striping and parking in Downtown Franklin. That was a comprehensive study of the situation and potential improvements. Thank you also for reaching out to the DNA to assist in improving this situation for residents, business owners and tourist. We are excited to be a part of the discussion.

Yesterday afternoon the Downtown Neighborhood Association board met and discussed your proposals. One message came loud and clear. The DNA would not be in favor of beginning the slippery slope of creating one-way streets unless they are absolutely necessary. Based on the day-to-day experiences of the people on the DNA board, Cummings Street does not fall into a category of "necessary". As a matter of fact, we believe the confusion of such a short street becoming one-way would more likely cause accidents that prevent them. As someone who walks and drives that short street regularly, I do not see a problem that needs to be ameliorated.

Also, as we briefly discussed in the meeting, there is a concern among residents who are losing parking in front of their homes. The increase in daytime parking on residential streets is likely due to the recent changes in parking options Downtown. The driving forces have namely been when previously free lots became paid lots and then the switch from 4-hour to 2-hour parking. To assist in creating solutions for residents, we put together an initial task force led by Walt Green to look at potential options to improve parking for residents. Specifically Mr. Green's group will be looking at other towns and cities that face similar situations to see how they have most effectively dealt with this problem. Mr. Green may add other interested parties to his task force.

Thanks so much for your concern for all of Franklin's citizens. I'm sure if you could wave a magic wand and multi-story, underground parking garages would materialize you would do that. In the meantime, we look forward to working together.
