Section 2. The "Shadow the Harpeth" shall be owned by Harpeth Office Associates LLC.


**Section 3.** Harpeth Office Associates LLC shall be fully responsible for installing the "Shadow of the Harpeth" and any future maintenance.


## "Shadow of the Harpeth"

The installation will be placed on the property of the Harpeth Square development that is set to debut with the opening of the hotel in 2019.



The cement inlay will be 7ft in length and 10ft in width. The bike rack will be 10ft 4in in length.



SUBJECT: Consideration of Proposed Public Art Installation at Harpeth Square, located at the intersection of

2<sup>nd</sup> Ave. N. & E. Main St.

#### **Purpose**

Per the Franklin Public Art Ordinance, proposed public art installations within the Historic Preservation Overlay require must be vetted by the Historic Zoning Commission (HZC) for a recommendation to the Board of Mayor and Aldermen. On April 8, 2019, the applicant requested consideration of a recommendation from the HZC to the BOMA for the proposed public art installation at Harpeth Square, located at the intersection of 2<sup>nd</sup> Ave. N. and E. Main St. in Downtown Franklin.

#### **Background**

The application proposes the installation of a functional and artistic bike rack that stylized to resemble the Harpeth River. The "Shadow of the Harpeth" installation is proposed at this location to promote cycling as a means of travel while incorporating the spirit and heritage of Franklin. It is proposed to consist of steel with blue powder-coated paint and to be situated at the Harpeth Square property adjacent to the existing Landmark Bank. The cement pad for the installation measures 70 sq. ft. (7'x10') and features a map of the downtown area in relation to the Harpeth River. A small flush-mounted plaque will also be placed inside the cement inlay, denoting the name of the piece, its artist, a small description of the piece, and the commissioning body (the applicant) and date. The bike rack itself will measure 42" in height at its highest point.

#### Recommendation

The HZC approved a favorable recommendation onto the BOMA for the proposed installation at its April 8, 2019 meeting.

#### **Purpose**

The purpose of this memorandum is to provide information to the Franklin Board of Mayor and Aldermen (BOMA) concerning Resolution 2019-46, approving the Shadow of the Harpeth Public Art Installation.

#### **Background**

The City of Franklin Public Arts Commission (FPAC) was established in 2017 to provide guidance and oversight for art projects which are for public display, outdoors in the City of Franklin. The Commission makes recommendations concerning all aspects of public art to the Board of Mayor and Aldermen.

In January 2019, a group from the current class of Leadership Franklin presented a proposal for the Shadow of the Harpeth art installation, a functional bike rack designed to resemble the Harpeth River. Located at the Harpeth Square Development, adjacent to Landmark Bank on First Ave North, the piece is made of steel with blue powder-coated paint. The cement pad for the installation will feature a map of downtown with the bike rack casting a shadow onto the map to mimic the actual river.

#### Recommendation

The Franklin Public Arts Commission voted to recommend approval of the Shadow of the Harpeth to the Board of Mayor and Aldermen, following review by the Historic Zoning Commission. The Historic Zoning Commission also voted to recommend approval.
