		Staff has chosen the National Research Center as the vendor and the NCS as the survey tool. This survey is standardized except for a few customizable questions, uses professional survey tools and metrics to ensure accurate results and focuses on eight (8) areas of community livability:  Community Engagement
		Survey Methodology  A Scientifically valid closed survey will be sent to 2,600 – 3,000 Franklin Households by mail. Households will be randomly selected ahead of survey distribution. Reminder postcards will be sent to those households and they will be given 1 month to return surveys. **Survey Timeline** 

November : Sign-up

December: Payment, Data Transmission, Survey Design

• January: Survey Notification & Advertising. End of January - Surveys out.

February: Surveying Active. Ends at end of month.

March: Data analysis, report writing.

April: Results delivered & integrated into budget.

#### Discussion:

- Goes to single family homes and apartments.
- May respond by sending in card or online.
- After closed group survey, all who wish may complete the survey online. The open and closed groups kept separate.
- NCS believes 20% is a good return: City goal is 25% return. It was pointed out the City has always had a 30% return.
- It was asked if the questions would be specific enough to get meaningful answers on the six goals.
- Concerned about getting valuable feedback from a standardized survey.
- Concern on basing decisions on a survey that captures such a small percentage of citizens that are usually connected to special interest groups.
- Promote and advertise to get the survey to the masses and social media.
- Staff will encourage a broad base of citizens to participate in the survey.
   Priorities should be set so everyone weighs in and not just special interests.
- Aldermen want to see the survey and provide feedback on the three customized questions.
- Suggestions included notifying HOA presidents, reviewing comparisons with like-cities using the same questions.
- · Important to contact residents without access to or no expertise on computers

Mr. Stuckey related the cost of the survey is approximately \$24,000, which is within his administrative authority to authorize without a vote from the Board. However, he wants most of the Board comfortable with the choice. The survey will be sent to the Board to review and weigh in on the development of the three questions.

Jonathan Marston gave a progress report on the updated design. The project was changed from a 5' sidewalk to a 10' multiuse trail and has been designed as an open ditch section to help reduce the construction cost and avoid relocation cost associated with overhead utilities. The design is 95% complete and utility coordination should be completed in January. Originally, there was to be a public meeting in December. Due to the proliferation of holiday activities in December, the meeting will be scheduled in late January 2016. Construction will take about 6 months. Staff submitted an application to the Nashville Area MPO to obtain a TDOT Multimodal Access Grant. Should the City receive the grant, up to \$1,000,000 could be available for the project. Easement acquisition could begin in January as well. There are 30 easements to acquire.

Accessory Dwellings - 2015-12-28

#### This Ordinance was acknowledged.

Kelly Dannenfelser and Bob Martin addressed this item. The City of Franklin Housing Needs Assessment recommends allowing accessory dwellings as a housing option for a healthy community. The Franklin Housing Commission recommended approval of this ordinance in August 2015. The concepts have been discussed at Joint Conceptual Workshops as well. The Central Franklin Area Plan recommends allowing accessory dwellings with criteria in appropriate locations. These include Special Areas 1, 2, 3, 7, and 8; however, only a portion of the properties (approximately 1,350 properties on 0.79 square miles) would potentially be impacted by this text amendment due to restrictions on residential zoning, minimum lot size, residential land use, etc. Accessory dwellings will provide a housing option for family members, supplement income via rent, or help aging residents meet their needs without moving.

## Discussion:

- Addressing resolved by adding the letter "A" to the principal address.
- Having enough space for parking was debated for certain size lots. Planning will recalculate.
- Language used in the ordinance was pulled from the Nashville Code.

This Contract/Agreement was referred to the Board of Mayor & Aldermen meeting on 1/12/2016.

Troy Mizell, property owner, was present. He and his wife Jody own multiple properties in the same area, and all are in the County except this one. Staff offers no recommendation at this time, as they continue to review the request and de-annexation's impact on the delivery of City services to residents and those in the urban growth boundary.

The request is to de-annex two five-acre lots to allow him to re-plot his property so it can exist in a contiguous manner, to use his land without creating any more property line violations (unfinished garage is too close to property line), keep all seven connected properties as County land, eliminate the doughnut effect from his property (his County land sandwiches his two City lots), allow him to conduct agriculture operations on one contiguous piece of County land. There are three high pressure gas lines on that 10 acres and nothing can be built on it, it floods behind the creek as well. He plans to put the land in trust for 50 years. None of the land around him is in the City.

There will be a public hearing at the January 12, 2016 BOMA meeting.
