### POPULATION AND EMPLOYMENT

Existing Land Uses – Reviewed existing land use information and field verified any areas of question – map included

Known Developments – Mapped known development agreements. Documented proposed number of units, building square footage, densities and FAR, Cross referenced information with current and past City Development Reports – map included.

Areas of Change – Using feedback from work sessions with planning and engineering staff, major areas of change were mapped and appropriate densities were applied – map included.

Vacant Parcels – Identified all vacant parcels using City GIS information. Assigned future land use to identified parcels based on existing zoning, surrounding uses, context, development feasibility, access and visibility - map included.

Mr. Truell explained the Policy and changes are due to GASB 67 and 68 and State of Tennessee Chapter 990 requiring every city must have a pension funding policy in place by July 2015. Staff recommends adopting the policy ahead of schedule so it can be reported in the upcoming audit. The draft policy was reviewed and approved by the Pension Committee. The Pension will be funded every year with an amount recommended by qualified actuaries. Asset smoothing is included in the policy; although it has not been done before, it will now be beneficial to do that. This item will be on the October 28 BOMA agenda.

Vice Mayor Petersen commented that the City's Pension Plan is in good shape. Mr. Truell gave kudos to BOMA for issuing the pension bonds. The plan went from 92-93% funded to over 100%.

Ordinance 2008-56 was approved in 2008. Since then, the Tennessee Office of Open Records Counsel has established a Schedule of Reasonable Charges for copies of public records. Staff recommends Ordinance 2008-56 be rescinded and replaced with Ordinance 2014-33 that lists a schedule of fees that more adequately conveys the actual cost to the City. A City employee must scan copies to know what is being released from the City. Electronic records can be emailed free of charge. If the request is for an abundance of records that involves hours of searching and gathering by a City employee, there will be a labor charge. The first hour of staff labor is free, however.

Most all departments receive requests for records. Personnel records are covered by state law and certain identifying information is confidential. There are state laws specific to police personnel and the Chief of Police monitors those requests to determine what can be provided.
