THIS AGREEMENT AMENDMENT is made and entered into this \_\_\_\_\_ day of \_\_\_\_\_, 20\_ by and between the STATE OF TENNESSEE DEPARTMENT OF TRANSPORTATION, an agency of the State of Tennessee (hereinafter called the "Department") and City of Franklin (hereinafter called the "Agency") for the purpose of providing an understanding between the parties of their respective obligations related to the management of the project described as:

**Safe Routes to School:** Hunters Bend Elementary School. Improvements to 2 walking tunnels including retaining wall, earthwork, lighting, emergency call box, and tunnel entrance rock surround.

1. The language of Agreement #120296 dated May 13, 2013, section B.1(a) is hereby deleted in its entirety and replaced with the following:

**"B.1 General Requirements:**

2. The language of Agreement #120296 dated May 13, 2013, section B.2(a) is hereby deleted in its entirety and replaced with the following:

**"B.2 Completion Date:**

- a) The Agency agrees to complete the herein assigned phases of the Project on or before May 12, 2016. If the Agency does not complete the herein described phases of the Project within this time period, this Agreement will expire on the last day of scheduled completion as provided in this paragraph unless an extension of the time period is requested by the Agency and granted in writing by the Department prior to the expiration of the Agreement. An extension of the term of this Agreement will be effected through an amendment to the Agreement. Expiration of this Agreement will be considered termination of the Project. The cost of any work performed after the expiration date of the Agreement will not be reimbursed by the Department."

All provisions of the original contract not expressly amended hereby shall remain in full force and effect.
