#### **ORDINANCE 2014-49**

TO BE ENTITLED, "AN ORDINANCE TO ANNEX THE ADAMS PROPERTY, CONSISTING OF 11.88 ACRES, LOCATED ON THE PROPERTIES ON THE SOUTH SIDE OF MURFREESBORO ROAD, IMMEDIATELY WEST OF RIDGEWAY DRIVE."

WHEREAS, the City of Franklin, Tennessee, has determined that it would be in the best interests of the City to annex 11.88 acres located south of Murfreesboro Road, on the three properties south of Murfreesboro Road, immediately west of Ridgeway Drive, and;

WHEREAS, this annexation will result in a residential development the site, and;

WHEREAS, there is a Plan of Services, an agreement regarding services and responsible parties to be considered with this annexation request, therefore:

### PREMISES CONSIDERED

SECTION I: BE IT ORDAINED by the Board of Mayor and Aldermen of the City of Franklin, Tennessee, that the following described property shall be, and is hereby, annexed in and to the corporate limits of the City of Franklin, Tennessee:

## LEGAL DESCRIPTION R. GLENN ADAMS, TRACT I

Situated in the Fourteenth (14<sup>th</sup>) Civil District of Williamson County, Tennessee and being a 5.789 acre tract, more particularly described as follows:
