#### TRAINING POLICY:

All beer applications must have a training policy submitted with application. This policy must include training regarding the sale of beer to minors.

- 19. Please read the following and upon signature of this application, you do understand and agree to comply if you are granted a permit.
  - (a) You will not sell beer or similar beverages except at the place or places for which the beer board has issued your permit.
  - (b) You will not sell beer or any like beverage except in accordance with the terms of said permit.
  - (c) If this application is made for permit to sell and not for consumption on the premises, you will not sell for consumption on the premises and not allow consumption on the premises.
  - (d) You will rigidly enforce the law against sales to minors.
  - (e) You will prohibit gambling at your establishment and understand that the conduct of such activities on the premises will result in revocation of your permit.
  - (f) You will secure a certificate or statement from the health department or health officer that the premises covered by the application meet the requirements of the ordinances of the City of Franklin and the laws of the State of Tennessee.
  - (g) You will not attempt to transfer this permit to anyone else.
  - (h) You will display this permit in a prominent place in your establishment.
  - (i) You will not sell or distribute beer between the hours of 3:00 AM and 6:00 AM (8:00 AM for on premises consumption) during the week and between the hours of 3:00 AM Sunday and 12:00 Noon Sunday (10:00 AM for on premises consumption).
  - (j) You will prohibit the congregation at your establishment of those who reasonably appear to be intoxicated, lawless, rowdy, or prostitutes.
  - (k) You will not allow any liquor with alcoholic content of greater than five percent (5%) to be consumed on the premises.

- (I) You will not allow any sale or delivery of beer for consumption on the premises outside of the building, it being the intention to prohibit the sale of beer by what is commonly known as "curb service" or "curb sales" of beer.
- (m) You will comply with all requirements of section 2-201 through 2-229 of the municipal code of the City of Franklin.

A non-refundable \$250 fee must accompany this application and the application shall be submitted at least fifteen (15) days prior to the Beer Board meeting at which it is to be considered. If the application is approved you are required to provide documentation of sales tax registration to the city within ten days of approval. Any applicant making false statement in this application shall forfeit his permit and shall not be eligible to receive any permit for a period of ten years.

A privilege tax of \$100 is imposed on the business of selling, distributing, storing or manufacturing beer in this state effective January 1, 1994 and each successive January 1. Any holder of a beer permit issued after January 1, 1994 shall pay a pro rata portion of this annual tax when the permit is issued.

I hereby make application to the City of Franklin Beer Board for a beer permit.

The signing of this application acknowledges that I am aware of the laws prohibiting the sale of beer to minors.

I hereby certify that no person having at least a 5% ownership interest, nor any person to be employed in the distribution or sale of beer in my establishment has been convicted of any violation of the beer or alcoholic beverage laws or any crime involving moral turpitude within the past 10 years.

I am also aware that I shall not be issued a permit or my permit shall be revoked if my business location causes traffic congestion or interferes with schools, churches, or other public places of public gathering, or otherwise interferes with public health, safety and morals.

### MAFIAoZA's FRANKLIN

#### Responsible Alcohol Service and Training Policy

Some states require a picture ID for any persons drinking alcoholic beverages regardless of age. MAFIAoZA's Franklin recommends that all of its guests be asked to show proper ID prior to service. Beer is to be consumed on premise and not to be sold as a to-go item.

#### Acceptable Forms of Identification

Driver's License with Picture State Issued Personal Information Unexpired U.S. Passport An Active Military ID

#### Policies Concerning Responsible Alcohol Service

- 1. The sale of alcohol to minors is prohibited.
- 2. The legal age to purchase alcohol in TN is 21.
- 3. No person under the age of 21 will be served alcoholic beverages.
- 4. Employees must ID anyone attempting to purchase an alcoholic beverage.
- 5. The sale or service of alcoholic beverages to intoxicated customers is prohibited.
- 6. Managers will visit any customer who has been served two (2) drinks within an hour prior to another drink being served so that the manager can evaluate the customer's level of intoxication.
- 7. All employees must report incidents to a manager and document them in an incident log within an hour of their occurrence.
- 8. Employees will offer to call a taxi, Uber, Lyft or other car service for any intoxicated customer at the customer's expense.
- 9. Employees will not physically restrain intoxicated customers to prevent them from leaving the establishment.
- 10. Employees will immediately notify a manager and will call the police to report any intoxicated customer who leaves the establishment and who gets behind the wheel of a motor vehicle.
- 11. It is against the law to serve alcohol to any person who is visibly intoxicated.
- 12. No alcohol is to be sold between the hours of 3:00 a.m. and 8:00 a.m. during the week and between the hours of 3:00 a.m. Sunday and 10:00 a.m. Sunday.
- 13. All servers and bartenders must present for inspection and copy their current TABC Card. If they do not have one, they must obtain one no later than 30 days after their first day of work.
- 14. No alcoholic beverages will be sold except in accordance with the terms of MAFIAoZA's Franklin's TABC and Beer Board permits.

### **Employee Coaching Tips:**

The primary legislative purpose of the Alcohol Server and Responsibility Act of 1995 is to prevent intoxication-related deaths, injuries, and other damages through responsible serving practices and awareness.

What does this mean for you?

- Knowing and following the laws which govern the industry in which you are employed is your responsibility. Claiming ignorance if a problem arises from your service or sale of alcohol is not a defense in the eyes of the law.
- Under Third Party Liability, servers can be held liable for a guest causing injury to themselves or others if it can be proven that the party involved was served alcohol illegally (minors or obviously intoxicated) or negligently (carelessly, irresponsibly, without level of care).

#### What can you do?

- Good ID checking practices: everyone should be carded, regardless of appearance, even if they have already been served by someone else or been sold to on previous occasion. You have the right to refuse service or ask for additional documentation if you are not satisfied with their identification.
- Condition & consistency if the ID is difficult to read, and inconsistent with the Driver's License Guide Book, you can refuse to accept it.
- Ownership does the ID belong to the person using it?
- DOB make sure that you know what day someone must be born on to be served alcohol.
- Expiration Date it is against the law to sell alcohol to someone with an expired ID, so always check the expiration date.
- Seals and Signatures these will be consistent across every ID issued from that state.
- Are there signs or impairment or intoxication? Have they already been drinking? If so, you may refuse service. If the guest is displaying any signs of impaired judgement or coordination, it is likely that they are intoxicated and should be refused service.
- High risk situations bachelor parties, fraternity & sorority groups, women, known alcoholics, young drinkers (21-25). Pay extra attention to these groups, as they are more likely to experience alcohol intoxication quickly.
- What is the mood of the guest? What is their condition and size?

#### Set the Pace

- Serve water with the first round of drinks and endeavor to keep them full.
- · Provide a MAFIAoZA's Franklin menu.
- · If a guest hesitates in ordering, offer non-alcoholic suggestions.
- Note the guest's reaction to drinks are they too strong?
- · Serve only one drink at a time.
- Never give away drinks.
- Never "keep'em coming."
- · ALWAYS get a manager if you are concerned about a guest's intoxication.

Note: This training policy is part of the MAFIAoZA's Franklin Employee Handbook that each employee receives upon their employment.
