About this Report

As part of its participation in The National Citizen SurveyTM, the City of Franklin conducted a mailed survey of 3,000 residents. Surveys were mailed to randomly selected households in September 2016 and data were collected through November 2016. Two weeks before the official data collection period was over and the data was reported (see the report, *The National Citizen Survey: Community Livability Report, Franklin, TN, 2016*), the City made available a web-based survey to its residents through a link on the City's website. Visitors to the site were able to complete the survey throughout October and November 2016 and 324 surveys were received.

This report contains the results of this administration of the web-based survey and have not been weighted to current population estimates of Franklin.

I would get rid of my ca tomorrow if transit were more comprehensive or walking was safer (Columbia Ave past Downs, hwy 96 from Pinkerton to 65). Thank you!
