Water Tap Fees

- Currently based on meter size.
- PROPOSED calculation is based on flow (gallons per day). 350 GPD = 1 Equivalent Residential Unit (ERU).

Sewer Tap Fees

- Currently based on meter size.
- PROPOSED calculation is based on flow (gallons per day). 350 GPD = 1 Equivalent Residential Unit (ERU).

Road Impact Fee

- Fees that are assessed on new development, and are also applicable to a change in use of a property, in order to assure the provision of adequate arterial road improvements or expansions to serve such new development.
- PROPOSED Fee Schedule includes the addition of collector roads.

Facilities Tax

- A proportionate tax based on the need for additional facilities created by new development and additions that extend beyond the original building envelope.
- Used to fund capital improvements made necessary by new growth including park, police, fire safety and sanitation facilities.
- No changes proposed.

Parkland Dedication

- Payment in Lieu of Dedication of Public Land for Parks and Greenways/ Blueways Residential or Mixed-use developments shall dedicate land to the city for use as public parks or greenways/ blueways, or, payment may be made in-lieu of the dedication of land.
- PROPOSED Calculation includes both Land Dedication and Park Development or proportionate fees.

Education Facilities Impact Fee

- Purpose is to meet the proportionate demand of new residential development for expansion or additional education facilities.
- Paid directly to Williamson County.
- Full assessment to be implemented September 1, 2017.

Williamson County Privilege Tax

- A tax on residential development to ensure that new development pays a proportional share for the cost of new and expanded public facilities made necessary by such development.
- Paid directly to Williamson County.
- No changes proposed.
