A RESOLUTION AWARDING THE CONSTRUCTION CONTRACT (COF CONTRACT NO. 2016-0276) FOR THE EAST MCEWEN DRIVE SAFETY ENHANCEMENTS PROJECT TO SUPERIOR TRAFFIC CONTROL, INC., IN THE AMOUNT OF \$93,267.70 AND ESTABLISHING A PROJECT CONTINGENCY IN THE AMOUNT OF \$10,000.00

WHEREAS, on July 28, 2016, the City of Franklin Engineering Department presented the results of a traffic and safety study for the section of East McEwen Drive, between Cool Springs Boulevard/Oxford Glen Drive and Wilson Pike, to the Capital Investment Committee (CIC); and

WHEREAS, the recommendations from this study included: new and larger warning signs, driver feedback signs, flashing beacons, centerline rumble strip, raised pavement markers, updated striping, and the installation of additional guardrail; and

WHEREAS, portions of these recommendations have been performed both in-house by City staff and by the Streets Department annual contractor; and

WHEREAS, the remaining items were combined into a single contract (COF Contract No. 2016-0276) to allow for competitive bids; and

WHEREAS, on February 20, 2017, sealed bids were received by the City of Franklin Engineering Department, 109 Third Avenue South, Franklin, Tennessee, 37064, and were publicly opened and read aloud for the East McEwen Drive Safety Enhancements Project (COF Contract No. 2016-0276); and

WHEREAS, after careful review and tabulation of all submitted bids, City staff recommends awarding the construction contract (COF Contract No. 2016-0276) to Superior Traffic Control, Inc., in the amount of Ninety-Three Thousand Two Hundred Sixty-Seven and 70/100 Dollars (\$93,267.70); and

WHEREAS, in the case of any unforeseen or changed project conditions, quantities, or cost overruns, City staff requests an additional Ten Thousand and No/100 Dollars (\$10,000.00) project contingency to allow for the expedient completion of the East McEwen Drive Safety Enhancements Project.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF MAYOR AND ALDERMEN OF THE CITY OF FRANKLIN, TENNESSEE, AS FOLLOWS:

SECTION I. Approval is granted to award the construction contract (COF Contract No. 2016-0276) to Superior Traffic Control, Inc., for the East McEwen Drive Safety Enhancements Project in the amount of Ninety-Three Thousand Two Hundred Sixty-Seven and 70/100 Dollars (\$93,267.70).

SECTION II. Approval is granted to create a project contingency in the amount of Ten Thousand and No/100 Dollars (\$10,000.00) for the East McEwen Drive Safety Enhancements Project.

SECTION III. Authority is granted to the City Administrator, City Engineer, and the Assistant Director of Engineering to review and approve the spending of all project funds, both in the bid award and from the project contingency, toward the completion of the East McEwen Drive Safety Enhancements Project.
