- Please read the following and upon signature of this application, you do understand 19. and agree to comply if you are granted a permit.
 - You will not sell beer or similar beverages except at the place or places for (a) which the beer board has issued your permit.
 - You will not sell beer or any like beverage except in accordance with the (b) terms of said permit.
 - If this application is made for permit to sell and not for consumption on the (c) premises, you will not sell for consumption on the premises and not allow consumption on the premises.
 - You will rigidly enforce the law against sales to minors. (\mathbf{d})
 - You will prohibit gambling at your establishment and understand that the (e) conduct of such activities on the premises will result in revocation of your nermit.
 - You will secure a certificate or statement from the health department or health officer that the premises covered by the application meet the requirements of the ordinances of the City of Franklin and the laws of the State of Tennessee.
 - You will not attempt to transfer this permit to anyone else. (g)
 - You will display this permit in a prominent place in your (h) establishment.
 - You will not sell or distribute beer between the hours of 3:00 AM and (i) 6:00 AM (8:00 AM for on premises consumption) during the week and between the hours of 3:00 AM Sunday and 12:00 Noon Sunday (10:00 AM for on premises consumption).
 - You will prohibit the congregation at your establishment of those who **(i)** reasonably appear to be intoxicated, lawless, rowdy, or prostitutes.
 - You will not allow any liquor with alcoholic content of greater than (k) five percent (5%) to be consumed on the premises.

- (l) You will not allow any sale or delivery of beer for consumption on the premises outside of the building, it being the intention to prohibit the sale of beer by what is commonly known as "curb service" or "curb sales" of beer.
- (m) You will comply with all requirements of section 2-201 through 2-229 of the municipal code of the City of Franklin.

A non-refundable \$250 fee must accompany this application and the application shall be submitted at least fifteen (15) days prior to the Beer Board meeting at which it is to be considered. If the application is approved you are required to provide documentation of sales tax registration to the city within ten days of approval. Any applicant making false statement in this application shall forfeit his permit and shall not be eligible to receive any permit for a period of ten years.

A privilege tax of \$100 is imposed on the business of selling, distributing, storing or manufacturing beer in this state effective January 1, 1994 and each successive January 1. Any holder of a beer permit issued after January 1, 1994 shall pay a pro rata portion of this annual tax when the permit is issued.

I hereby make application to the City of Franklin Beer Board for a beer permit.

The signing of this application acknowledges that I am aware of the laws prohibiting the sale of beer to minors.

I hereby certify that no person having at least a 5% ownership interest, nor any person to be employed in the distribution or sale of beer in my establishment has been convicted of any violation of the beer or alcoholic beverage laws or any crime involving moral turpitude within the past 10 years.

I am also aware that I shall not be issued a permit or my permit shall be revoked if my business location causes traffic congestion or interferes with schools, churches, or other public places of public gathering, or otherwise interferes with public health, safety and morals.

Subject: Alcohol Sales

The following rules will be in place and enforced on the premise at all times.

- No alcohol sales to any person under the age of 21 (ID will be required for all alcohol sales)
 - O Checking ID Must be a valid driver's license or a State issued ID
 - Alcohol will not be sold to any person with questions regarding age or form of ID
 - Check ID for alterations or damages especially to the date of birth or type styles that do not match
- Alcoholic beverages may not be sold to someone you suspect is buying it for underage people
- Alcoholic beverages will not be sold to intoxicated persons
- Alcoholic beverages will not be sold or consumed between the hours of 3:00 am and 10:00 am
 on Sunday
- We will not allow any liquor with alcoholic content of greater than five percent to be consumed on the premises
- Each person will be stamped or marked with permanent ink at the time of the sale of all alcoholic beverages
- No person will be allowed to purchase a tower adventure pass or use a tower adventure pass once they have purchased any alcoholic beverage
- No person under the age of 18 will be allowed to serve alcohol.

All alcoholic beverage serving staff will be trained along with possible actions that can be taken should any conflict arise from the state rules above. Those actions include the possibility of calling 911 if a person becomes violent or threating.
