CALL TO ORDER

Mayor Ken Moore called the December 13, 2016, meeting to order at 7:00 p.m.

INVOCATION

The invocation was given Alderman Clyde Barnhill.

PLEDGE OF ALLEGIANCE

Mayor Moore led the Pledge of Allegiance to the Flag of the United States of America.

• Michael Phillips, 417 Gambrel Court: Mr. Phillips believes the Board lacks checks and balances, establishes policies and doesn't follow them. The Board approved a development plan for the Iron Horse development despite being in conflict with the Land Use Plan regarding the parallel driveway, size and height of the buildings.

APPROVAL OF MINUTES

1. 16-1024 Alderman Petersen moved to approve the November 22, 2016 Work Session and November 22, 2016 Board of Mayor and Aldermen minutes as presented. Seconded by Alderman Barnhill. Motion carried unanimously 7-0.

RECOGNITIONS

Mayor Moore related several City employees are retiring this month. He recognized three of the soon to be retirees:

- Ray Foglia, Cable TV Production Operations Supervisor
 - Mr. Foglia's picture was shown on the big screen. During his 16 years with the City he has never been seen during a BOMA meeting he's the man behind the camera. He created the first cable TV station for the City, and did so almost singlehandedly. He is helping the City transition to HD quality video feed before he goes.
- <u>Shirley Harmon-Gower, Human Resources Director</u> Ms. Harmon-Gower, during her nearly 12 years with the City, has monitored pension retirement payments, made significant improvements in employee healthcare insurance and the risk management program with great skill. She is known for saying, "our people are our most important resource". She said she enjoyed every minute working for the City.
- <u>Russ Truell, ACA Finance and Administration & CFO</u> Mr. Truell was accompanied by his wife, Martha. During his 13 years, he has had significant financial impact on the City and the employee pension plan, and has been very involved in state and national financial organizations. He said the City gave him an opportunity to do things at a state and national level that he wouldn't have had otherwise.

Many good things were said about these individuals and their accomplishments. All three received standing ovations from the Board, staff, and all who were present. They will be missed.

Kristine Tallent was recognized. She has been hired to replace Mr. Truell as ACA Finance and Administration & CFO for the City of Franklin.

Alderman Martin said she would not support this because she opposes building in the flood plain. It is not good for this area, and not a good practice to set a precedent for 16 houses.

Motion to approve Ordinance 2016-40 carried 6-1 with Alderman Martin voting against on Second of Three Readings.

8. 16-0871 PUBLIC HEARING: Consideration of RESOLUTION 2016-66, To Be Entitled, "A Resolution To Approve A Revised Development Plan For Rizer Point PUD Subdivision, With Two

Modifications Of Standards (MOS-1 Connectivity; MOS-2 Cul-de-Sac Length), For The Property Located North Of Del Rio Pike And East Of Del Rio Court."

Public Hearing

- 1. Michael Phillips, 417 gambrel Court: Took issue with MOS 2-cul-de-sac length. Follow policy for safety of the citizens. The length is to build more houses and push them closer to Wedgewood Drive.
- 2. David Eble, 3009 Nive Bank Lane, Rizer Point: The proposed properties are used for dirt bikes and to dump garbage. They don't want to be responsible for upkeep.
- 3. Ed Saffell, 5013 Rizer Point Drive: Three petitions were submitted and he didn't see the one with 20 residents of Wedgewood. Biggest objections: Wedgewood, Rebel Meadows and Rizer Point don't want the extra land and don't want to be cut-through neighborhoods.
- 4. Ron Coffman, 1109 Wedgewood Drive: Against connectivity. There are no sidewalks and streets are not walkable. No benefit to have City services for the 88 families living there. Traffic backups already.
- 5. Greg Gamble, 716 Hampton Cove, representing Goodall Homes: This is the second version, and the floodplain is 1,300 feet back where it goes into open field. It is entirely green and is part of an agreement. Just a small portion in the PUD, about 150-200 feet and at another border of the property is floodplain. The HOA covenants will specify the open space is maintained by the owner of the property, not the existing homeowners.

With no one else coming forward to speak, Mayor Moore declared the Public Hearing closed

Alderman McLendon moved to approve Resolution 2016-66 with Comment. Seconded by Alderman Burger.

Alderman McLendon said ultimately he thinks they can do what most everyone wants with the Modifications of Standards. The intent to allow the length of the cul-de-sac, and require only an emergency entrance, and ensure current residents of Rizer Point not be responsible to maintain any common area or informal open space. The reason for the cul-de-sac and only an emergency entrance is for safety.

Alderman Petersen moved to approve Modification of Standard-1 Connectivity, allowing a cul-desac and emergency entrance with crash gate. Seconded by Alderman McLendon. Motion carried unanimously 7-0.

Alderman Petersen moved to approve Modification of Standards-2 Cul-de-Sac Length. Seconded by Alderman McLendon. Motion carried unanimously 7-0.

Alderman McLendon moved to add a Condition to Resolution 2016-66 that prohibits the current residents of Rizer Point from being responsible for any and all maintenance of the adjacent vacant green property. Seconded by Vice Mayor Bransford. Motion carried unanimously 7-0.

Motion to approve Resolution 2016-66, including Modifications of Standards 1 & 2, and Condition, carried 6-1 with Alderman Martin voting against.
