#### 3. 16-0542 City of Franklin Recognized by Governor's Foundation for a Healthier Tennessee

A Mayor Moore introduced Mindy Tate, Franklin Tomorrow (Get Fit Franklin), and said a year ago Franklin was selected by the Governor's office to act as a pilot community for Healthier Tennessee, for the Governor's Foundation for Health and Wellness. Franklin, along with Franklin Tomorrow/Get Fit Franklin, Vanderbilt Health, Blue Cross/Blue Shield, Williamson Medical Center and Healthcare Council implemented some plans. From those plans a program was developed The Governor and the Foundation recognized Franklin, Tullahoma and Hickman County on June 1 as being Healthier Communities in Tennessee.

The City was given a Healthier Tennessee Community plaque, a Healthier Tennessee Community sign to display and a Healthier Tennessee Community flag that the Governor said he wants to see flying when he visits the community.

Ms. Tate said the Program focuses on increased physical activity, healthier eating choices and cessation of tobacco usage. According to County Health Rankings, Franklin is the healthiest City in Tennessee. However the State is 37th.

Michael Walters Young explained that the State allows this fund to be unbudgeted because projects can take more than one fiscal year. All the ins and outs come to BOMA. Several funds flow into this. At the beginning there was a deficit and they are trying to get it back into a positive. A bond issuance would get it to positive. This fund tends to fluctuate. This amendment addresses that and is accounted for in the guarterly and annual reports.

There will be a cap placed on total base pay increase of \$3,000 between these two elements. The pay adjustment will be effective July 1, 2016.
- The recommended budget includes \$125,000 for funding of merit supplements for a fifth consecutive year.

#### **INVEST FRANKLIN**

- Five Year reappraisal has occurred (still in process).
- Due to increased property values, the existing \$0.4065 per \$100 of assessed valuation will move to approximately \$0.3176 per \$100 of assessed valuation.
- Invest Franklin provides for a \$0.10 increment of property tax bringing the new rate to \$0.4176 per \$100 of assessed valuation.

Alderman Petersen referred to the Property Tax Rate Summary slide noting property tax last year was \$14,540,412, and with the new rate it will be \$18,951,680, an increase of \$4,411,267. She has concern about where the increase will be used. She doesn't want the extra money to just pay debt service. Use some for pay-as-you-go projects. Pay off some debt. In 2000 the City had \$20 million in debt. Last year debt was at \$145 million. We need to recognize how much debt has to be paid the debt service every time. This is an opportunity to do some things and she wants it to be used wisely.

Alderman Burger related a request from the Masonic Lodge was placed in appropriations for \$15,000. All things are worthy, but the Lodge is privately owned. That opens a Pandora's box to fund a private entity. It could cause future problems should someone else that owns historic property make a request.

Alderman Burger moved to remove the Masonic Lodge Historic Study item from Appropriations. Motion failed for lack of a second.

Alderman McLendon commented that he doesn't love everything in the Budget and agrees with Alderman Burger, but overall the Budget is fine.

Motion to approve Ordinance 2016-012 carried unanimously on Second of Three Readings.
