- 15. Maintenance of all storm water management features shall be the responsibility of the property owner(s) or HOA.

The property owner or H.O.A. shall be responsible for repairing and/or replacing any such landscaping fencing concrete or other structures removed or disturbed by the City of Franklin in common open space lots and in areas owned by the property owner or
