- CCF 041: Additional pipe removal at existing filter building pipe gallery (1 day)
- CCF 046: Remove existing filter media including LS proposal from Eagle Industrial Services and Judy Construction OH&P to facilitate the work (7 days)
- CCF 048: Addition of electrical to include HS pump thermistors and motor heaters as requested (2 days)
- CCF 049: Addition of one turbidimeter; including installation, piping, programming, setup, testing (2 days)
- CCF 051: Time and material performed by Judy Construction to complete concrete repairs within the existing clearwell (3 days)
- CCF 052: Time and material performed by Judy Construction to complete pipe gallery demo within the existing WTP filter building (7 days)
- CCF 056: Remove and dispose of backwash troughs and surface wash systems at existing gravity filters; completed on a time and material basis(2 days)
- CCF 058: The addition of two (outside & inside) eyewash shower fixtures at the peroxide building; install includes valving and venting modifications required (14 days)
