Company agrees to install the specified System on the Premises and to make any necessary inspections and tests to deliver System to Customer in operating condition in accordance with standard installation procedures of Company. If existing security system and/or security equipment is to be incorporated into the installation of the specified System, the Company will test and inspect the existing security system and/or security equipment meet(s) the quality standards of the Company. The Customer agrees to give the Company a completed information sheet and to update it as necessary. The Company is entitled to rely solely on the Customer's information contained on this sheet and shall be under no duty to conduct any investigation into the accuracy of completeness of such information. The Company is not responsible for any interruption of the service due to any cause beyond the Company's control, whether foreseeable or unforeseeable, such as faulty telephone lines or any damage or destruction to the Company's equipment or facilities. The Company is not required to supply monitoring service to the Customer whose understands that not offer any interruption continues.
