A RESOLUTION AUTHORIZING THE USE OF THE FY 2019 ON-CALL ANNUAL CONTRACT FOR PAVEMENT PRESERVATION (COF CONTRACT NO. 2018-0036) PRIOR TO JULY 1, 2018

WHEREAS, on April 24, 2018, the City of Franklin Board of Mayor and Aldermen approved Resolution 2018-20 to award the FY 2019 On-Call Annual Contract for Pavement Preservation (COF Contract No. 2018-0036) to Jarrett Builders, Inc.; and

WHEREAS, the City of Franklin Streets Department has funds remaining in its fiscal year (FY) 2018 annual operating budget that were allocated to pavement preservation; and

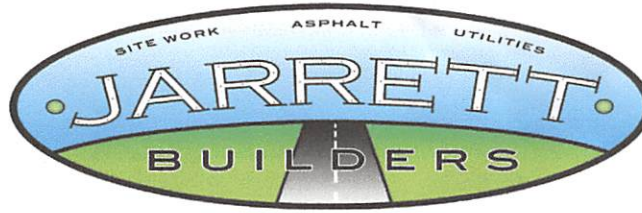
