AGREEMENT FOR DEDICATION OF PUBLIC DRAINAGE AND ACCESS EASEMENT COF Contract No. 2017-0092

That for and in consideration of the sum of **TEN Dollars** (\$10.00), in cash in hand, paid and other good and valuable considerations, the receipt and sufficiency of which is hereby acknowledged, **Cool Springs Real Estate Assoc.**, **LP**, does hereby grant, bargain, sell, transfer, and convey unto the CITY OF FRANKLIN, TENNESSEE, its successors and assigns forever, a permanent easement on the entirety of Lot 244 of the Cool Springs East Subdivision Section Six Final Plat recorded at the Williamson County Register of Deeds office under Plat Book 23 Page 56, which is made a part hereof.

This conveyance includes the right of the City of Franklin, Tennessee, its servants and agents to construct, operate, maintain, repair, replace and inspect infrastructure and improvements for the Jordan Branch Stream Restoration Project within the limits of the aforedescribed permanent easement.

To have and to hold said easement to the City of Franklin, Tennessee, its successors and assigns forever. I/We do hereby covenant with said City of Franklin, Tennessee, that I/we are lawfully seized and possessed of said land in fee simple and have a good right to make this conveyance.

I/We do further covenant with said City of Franklin, Tennessee, that said portion or parcel of land as aforedescribed is to remain the property of the undersigned and may be used for any lawful purpose(s) desired after the construction of all the aforedescribed improvements, provided, in the opinion of the City of Franklin, Tennessee, said use or uses do not destroy, weaken or damage the above mentioned improvements or interfere with the operation or maintenance thereof. The City of Franklin, Tennessee, hereby covenants that upon completion of construction it will restore the hereinabove described property to its original condition, or near thereto as is reasonably possible. I/We do not waive any claim for damage in any manner for the negligence of any agent, representative or contractor for the City of Franklin, Tennessee, during the construction of any of the aforesaid improvements. I/We do further covenant and bind myself/ourselves, my/our heirs, and representatives to warrant and forever defend the right of the grantee to the foregoing easement against the claims of all person whomsoever.
