#### Call to Order

Mayor Ken Moore called the Work Session to order at 5:00 p.m.

#### **Citizen Comments**

John Thompson, The Pawfect Puppy, 790 Jordan Road, Franklin: Mr. Thompson and his wife are opposed to the proposed City ordinance banning the sale of dogs and cats in pet stores. He gave a brief history of the pet store, as well as his education and experience. Handouts were provided. He takes issue with what the speakers said at the last Work Session and the news stories after. The dogs he sells come from licensed breeders in the Franklin and Brentwood area. Their store is licensed and inspected by various entities. The proposed City ordinance would restrict his sales, and would involve getting dogs from animal rescue and welfare. They are not regulated or inspected. Every breeder he does business with must have the animal examined by a veterinarian and sign a dog disposition form. In addition, a veterinarian works in the store two days a week for full examination of the puppies coming in. He could not maintain his license if the dogs came only from local shelters or rescue. The number of puppies available would be limited, and he would not have a complete history for each animal.

- Alderman Burger: Puppy breeding mills don't have to let dogs out of the cages. She would like to see breeder records and have information on the breeders. One of his breeders was on the horrible 100 list. Most responsible breeders aren't selling to pet stores.
- Vice Mayor Martin and Alderman Blanton asked questions and commented as well.
- Mr. Thompson said a bill sponsored by the Humane Society and animal activists in Tennessee, called the puppy mill ban, was voted down by State Committee and didn't make it to the floor. An ordinance to ban was overturned in Georgia as well.

- County inmates picked up 94,241 lbs. of litter countywide in 2017 (roughly 4,600 trash bags)

#### Discussion

- Alderman Blanton asked why only one plan was being presented instead of two as presented at the public meeting.
- Lisa Clayton explained the likes and dislikes of the public were taken into consideration and the two were combined into this plan.
- Mr. Fritz added that most people objected to concept one. Placement of the neighborhood park was questioned and the pickleball court was moved away from the big fields and traffic. Based on public comments they tried to bring back the best of both concepts.
- > They are confident there will be no parking problems.
- > Consideration was given to placement of the potential water reclamation plant even though all elements of that will be enclosed.
- Alderman Barnhill wants to make sure the Franklin Cowboys are not short-changed as they have been for years. That there will be enough fields for them. He was assured there are enough fields.
- > Mr. Fritz commented that one of the driving forces is to give the Cowboys space.
- Alderman Burger asked why there wouldn't be tennis courts.
- > Ms. Clayton responded there will be tennis courts included in the FSSD/City park.
- Alderman Burger suggested corporate sponsorships to name the park.
- Mr. Stuckey said this is will be a 260-acre park that is unique with a lake, passive park, neighborhood park, and sportsplex, which could have individual names under the umbrella of one specific name for the entire park.
- Mayor Moore related that he met with people that are interested in an inclusive playground for children and adults with different abilities.

# 5. 18-0175 Discussion and Guidance on Modifying the City of Franklin's Hours of Construction, Specifically Reducing the Current Subjectivity Associated with Staff Having to Determine Whether Construction Noise is a Nuisance.

Hours of Construction in current Ordinance:

Monday – Friday 7:00 AM – 6:00 PM Saturday 9:00 AM – 6:00 PM No Work on Sundays and City Holidays

#### Challenges

- Spending an inordinate amount of time policing construction sites and workers.
- Difficult to discern "noise" consistently. Current ordinance is too broad "...would not result in any loud, disturbing, or unnecessary noise."
- Delivery of building materials and heavy equipment to construction sites frequently occurs prior to and after hours.
- Construction site thefts are an ongoing problem and difficult to determine who is to be working vs. who is doing something malicious.
- Current penalty/fine not a deterrent. Contractors would rather pay \$50 fine than comply with ordinance.
- After some homeowners occupy their new home it is not uncommon for them to add porches, patios, pools, and other improvements that generate noise like the new homes under construction in the area. The City's current ordinance does not distinguish between owner-occupied versus unoccupied or new buildings under construction.
- Sometimes difficult to distinguish between ordinance exceptions. For example, Landscaping Work. "Use of domestic power equipment (including, but not limited to, power lawn mowers, leaf blowers, trimmers, snow blowers, tillers, saws, sanders, drills or similar devices) between 7:00 a.m. and 9:00 p.m." 7 days of week, including holidays.

#### Discussion:

- Residential isn't regulated.
- ➤ Look at a tiered approach: if more than 2 citations in a 12-month period, require developer to hire a private security firm. If private security firm fails to do its job, then issue stop work order, with the developer talking to the City.
- There are modifications every week for a good reason; more latitude in non-residential development.
- Residents around the Second Avenue Garage have complained about people cleaning the garage at 4:30 a.m. It was suggested the residents receive a letter in advance of garage cleaning stating the hours it will be done each quarter.
- > There is no clarification for City facilities and emergency repairs.
- > Consistency in hours and differentiate between inside and outside.
- > City and utilities should be an exception.
- Continue with modifications at the City Administrator's discretion.
