The ordinance removes parkland requirements from the Zoning Ordinance. FMPC and staff recommend approval.

This ordinance, as amended, adds parkland requirements to the Municipal Code. <u>Public Hearing</u>

With no one coming forward to speak, Mayor Moore declared the Public Hearing Closed

Vice Mayor Martin moved to approve Ordinance 2016-25. Seconded by Alderman McLendon.

Discussion:

Once again there was lengthy conversation on the 100% vs. 75/25. Shauna Billingsley reiterated information on nexus, the importance of having data to back up requests to change where the money is allocated rather than where it originated.

It was again pointed out that there are other sources for park funds from facilities taxes and hotel/motel funds.

Staff is to gather data from the different youth sports organizations as to where the players reside within the City. This information will be key when making decisions on parkland funds.

Ms. Billingsley noted it is important for the developers to get offsets that they aren't getting currently. The more they put in their neighborhoods the more offsets they get.

Motion to approve Ordinance 2016-25 carried unanimously on Second and Final Reading.

Eric Stuckey pointed out some budget highlights. He will give a more detailed report the second reading/public hearing.

- FY19 proposed budget for all funds is \$152,572,551. Represents a decrease of 2.8% compared to FY18. The General Fund budget is \$70.55 million, an increase of 1.7% compared to FY18.
- The budget is balanced
- Is in compliance with BOMA's debt and fund reserve policies, significantly exceeding the reserve requirements.
- Property tax remains unchanged at \$0.4176 per \$100 of assessed valuation.
- Overall, the proposed budget has a net increase of 4.5 positions across all funds
- Includes a general pay increase of 2.5% plus an additional performance-based pay increase of up to 2.5%. Includes full implementation of updates to City's compensation plan.
- No increase to health insurance premiums.

• Residential trash fee will increase from \$17.50 to \$19.00 per month. For the first time, there will be no general fund subsidy for SES.

Motion to approve Ordinance 2018-10 carried unanimously on First of Three Readings.
