The gentlemen related the story of how this proposal came about after the dreadful events that occurred in Charlottesville, Virginia, last year. They want to take a proactive approach to make sure the same thing will not happen in Franklin, Tennessee. The goal is unity.

The following two pages show what they want to accomplish with *A Fuller Story*. Each of the men spoke from the heart about this important piece of Franklin's history and Civil War history that will add four historical markers on the Square, and placement of a statue of a United States Colored Troops soldier at a yet to be determined site. There were 300 men from Williamson County in the United States Colored Troops.

A FULLER STORY


PURPOSE: To increase unity in our city by providing a more complete telling of our Civil War history.

United States Colored Troops:

Around 300 Williamson County residents, who were either freed slaves or escaped slaves, served in the Union Army during the Civil War. Their story is just now being told. Their story needs to be heard. 1867 Riot: On July 6, 1867, after a delayed July 4th parade and political speeches, a race riot broke out on the square injuring several people and killing one person.






Reconstruction & Jim Crow: Following the Civil War the 13th, 14th, and 15th Amendments were passed and ratified. In 1877 Reconstruction ended and the Jim Crow Era soon began. It was during this time that separate restrooms and separate water fountains were in Franklin.

The ultimate goal of a "Fuller Story" is to erect a statue of a USCT Soldier.

The goal is for this soldier to be placed inside the City Limits.

The exact location has yet to be determined.

Why a "Fuller Story"

After the tragic events in Charlottesville, VA last August, conversations started happening in Franklin about how our city would (or would not) react if something similar happened here. In a lot of ways our city is like Charlottesville. These discussions led to the thought that it would be better to be "actionary" instead of "reactionary." The result of these conversations led to the idea that instead of taking down historical markers, what if we added to them and told a "fuller story." Further, it was believed that the CHURCH in Franklin should lead this effort.

Over the course of this past year we have initiated further dialogue between...

- ...pastors and church leaders.
- ...the historical community in Franklin and Williamson County.
- ...the city administrator, city mayor and county mayor.
- ...the downtown business community.
- ...and a host of individuals.

Timeline

Phase 1 (four historical markers around the downtown square) – A dedication of these markers on Monday, January 14, 2019 during the CHURCHES' annual Martin Luther King Day Celebration. The four markers are:

- United States Colored Troops
- 1867 Downtown Riot
- Courthouse and Market House
- · Reconstruction and Jim Crow

Phase 2 – Erect a statue of a United States Colored Troop soldier at a yet to be determined
location inside the city limits of Franklin. A dedication of this statue on Monday, January 13,
2020 during the CHURCHES' annual Martin Luther King Day Celebration.

Present "Fuller Story" at BOMA Workshop on Tuesday, August 14, 2018.
Present "Fuller Story" to County Commissioners on Monday, September 10, 2018.
Announce fundraiser for the USCT statue September / October 2018.
A fall "revival" with the CHURCHES in Franklin / Williamson County.

The Ask

We are asking you, the city leaders, to lend your support behind our efforts and to help us with the locations of the markers and the statue. We are not asking the city for any money. All funds will be raised through private donations.

- Alderman Bransford supports this educational opportunity to teach citizens and visitors the true story. Many children do not learn this part in school.
- Alderman Burger thanked to group. This is important to the whole story.
- Alderman McLendon hopes they will be able to find a location for the statue of
 equivalent nobility as the Confederate Soldier on the Square. He asked if the 300
 USCT soldiers were buried together at a specific location. If so, he suggested
 some type marker symbolic marker be placed or the statue of the USCT soldier
 looking over his fallen brothers.
- Alderman Blanton added this is one more leg to telling the whole story. Concurs with Alderman McLendon on placing a marker in the cemetery. She remembers the race riot in Franklin in the 1960s.
- Other pastors working on this project were in the audience. They were asked to stand and be recognized.

The group will keep in touch as to the next steps to be taken.

2. 18-0668 Discussion and Consideration of Various Design Elements, including Bike and Pedestrian Facilities, Utility Relocations, and Access Management, for the Columbia Avenue Widening and Improvements Project.

Paul Holzen, Director of Engineering Jonathan Marston, Assistant Director of Engineering William Banks, Staff Engineer II

Staff reached out to stakeholders and others. Need input from BOMA on access management, overhead/underground utilities, roadway options, and sidewalks to move this forward to the design phase.

Paul Holzen noted the Board approved curb and gutter to curb and gutter in 2017. Need direction on whether to include bike and pedestrian trails/lanes.

Mr. Holzen and Jonathan Marston presented roadway options A, B, C, and AA, BB, CC: <u>Underground</u> -

The 4' finishing zone is for poles, etc. Also shown on the drawings were conceptual underground utilities, which would be buried in the roadway. Option C is consider urbanized with the sidewalk right at the curb.

Discussion:

- Both overhead and underground utilities take the same space as easement. Overhead utilities would be right behind the sidewalk. Light poles are not possible with Option C.
- Costs are unavailable right now; however, the State is paying 20% and federal paying 80%. The City would pay for enhancements. Underground utilities cost is around \$10 million, and the City would be responsible for payment.
- Alderman Blanton: This is more an industrial area. Residential is sparse. Doesn't
 believe children, dogs and strollers would abound. Eliminate 12' sidewalks and
 grass strips. Do the job as best we can without impacting the people along the
 corridor. Many businesses are lacking sufficient space for parking as it is.
 Sidewalks on just one side of the street. Access is the main issue.
- Alderman Speedy noted this is an established industrial part of the City. Engage
 the business owners. Agreed sidewalks on one side sufficient. Get the design
 and construction done quickly. It is an opportunity, even though costly, to do
 underground utilities. Mack Hatcher will expand and this will be a gateway to
 that part of the City.
- Alderman Petersen: Agreed about the sidewalks that there won't be people
 walking from place to place there. Doesn't agree with underground utilizes. As
 to access, looking at the examples, some businesses will have no access.
- Alderman Burger: What is expected for that area in 20-30 years? Will it be promoted as more industrialized? If so keep utilities above ground. Agrees sidewalks on one side.
- Vice Mayor Martin agrees there should be underground utilities. This will be the
 only opportunity to do it. Sidewalks may not be needed on both sides. Many
 apartments are being built in that area, so one sidewalk for the residential in the
 area.
- Alderman Barnhill: Difficult to justify spending \$10 million on underground utilities.
- Alderman Bransford asked about pedestrian trails, bike lanes, and she supports the utilities underground. One sidewalk.
- Alderman Barnhill suggested the underground utilities be placed on the CIP list.
- Alderman McLendon: This is a vehicle traffic improvement project to make adequate traffic improvements without significant damage to businesses. Access and parking are crucial. This is too far removed from downtown for pedestrian traffic so no multiuse trails. Looking for narrower roadway to preserve parking and access points. Agreed with adding underground utilities to the CIP list.

All access points on the corridor were reviewed from the intersection of Hillview Lane and Mack Hatcher north to approximately a block short of Fairground Street:

- Chili's and Regions Bank no access on Columbia will feed from access road to signalized intersection next to First Tennessee Bank. On the other side, Williamson Funeral Home main access will be at the north side of the complex.
- Kroger Fuel has full access right in/right out.
- Chick-Fil-A off Shadow Green Drive at signalized intersection of Shadow Green Drive and Southeast Parkway.

- Keeling Company access shift access to Southeast Parkway.
- Burger King being kept as a right in access.
- Advance Auto Parts to Alpha Drive.
- Car Bazaar and Corner Pub share access at Alpha Drive as do the Guidance Center and Quilting Squares and the private residence access share to Century Court. The Mane Event Salon on the other side access Century Court as well.
- Crutcher's Auto Repair loses access to Columbia and access goes to Century Court.
- Dollar General and Auto Masters access is across from Dollar General and Porter Paints with shared access.
- O'Reilly's Auto Parts access is on side street. Village Place needs right in as there is no signal at Beasley Drive.
- YMCA Soccer fields access to the north.
- Rolling Hills Community Church two access points one north and one south.
- Median with access to Franklin Business Park at future signalized intersection into Longview Development. Lasko access there as well.
- Confederate Drive/ Werthan Circle intersection, Fritz's European Auto Repair and Hardee's access.
- Cameron Car Wash and Kubota/Franklin Equine go to Carr Avenue
- TMA Group (County) share access with Moody Tire right in/right out.
- True Value full access on Downs Boulevard. And right in/right out for True Value Garden Store.
- NAPA Avondale Avenue access. Access C & F Tire via private drive intersection with Downs Boulevard.
- Lankford Motors vacant.
- Tim's Market & Deli access Avondale Avenue

Discussion:

- Alderman Blanton: Suggested a separate meeting to find out who will be affected
 most. Look at the narrowest section with sidewalk on one side. Supports
 underground being put on the CIP list. Option C with question of sidewalk on one
 side or both.
- Alderman Burger: Engineering should talk to the people about the access points prior to the Board getting input about access points.

Citizen Comments:

- Pam Stephens, 3009 Columbia Avenue, Franklin, co-owner Williamson Memorial Funeral Home: In favor of a sidewalk on one side, to a degree. Not in favor of bicycles. There are apartments coming in and they should be paying taxes. The City and Aldermen should come talk to business owners before the Board votes. The business owners have been in business a long time and are leaders.
- Neil Kornutick, 205 Scruggs Avenue, Franklin: He read from a section of Envision Franklin that deals with connectivity, etc. Walking and biking should be a priority as it benefits health and mortality rates. Compare cost of driving versus riding a bike. Advocate for bike lanes and sidewalks.

Resolution providing a grace period for mobile food vendors until the end of 2018 or until an ordinance is established, whichever comes first.

Staff will reach out to vendors for input.

Comments:

- Mark Mogul, 9416 Gentlewind Drive, Brentwood, TN, Tiny Little Donuts mobile food establishment: They want to be part of the community. Most of their 8,000 customers are local and repeat customers. Specific regulations are requested. He noted the parking lot where they set up is an eyesore. It could be cleaned up and up to four mobile food establishments could sell from there. It is cumbersome to pack up everything and move it off the property daily. They look forward to meeting with City staff.

An updated or new City Hall was placed on the CIP list several years ago. \$250,000 is budgeted to assess what would be needed for a new or renovated facility.

Discussion:

- Alderman Barnhill: The City has already done a lot of consulting for City Hall. He
 has a problem spending \$146, 868.00 for what we already know to move
 forward.
- Eric Stuckey pointed out it is not just for the condition of the building, but going forward.
- Alderman Burger: Money should be spent on what is needed and how it will look. When discussed previously there was to be a public/private partnership. Leave City Hall on the square. What would be the cost to operate during construction?

- Brad Wilson: We are at the point of looking at facilitating, which is part of this service. Staffing costs, utilities, etc. would be part of that. Not ready for the architectural piece yet.
- Mr. Stuckey: This building is well past its structural life. We could look at cutting
 that piece. Revise and eliminate or shorten that component. There is no interest
 in relocating City Hall to another site.
- Alderman Barnhill thought there should be something on this site that generates taxes and put City Hall close to Police Headquarters.
- Mr. Wilson noted that the Planning and Engineering departments have some good ideas for a new facility.
