Two Options from which to choose:

- A. Increase to Customer Charge Only
- B. Split the Increase between the Customer Charge and the Volumetric Rate

- Eric Stuckey related staff recommends either option as both meet the revenue target in the Cost of Service Study and in the five-year plan just adopted.
- Alderman Petersen: Option B is the one that keeps the minimum amount to the minimum use lowest.

Alderman Petersen moved to approve Ordinance 2018-47, Option B. Seconded by Alderman Bransford.

- Alderman Petersen noted historically we have kept the minimum fee low because some people are in situations where \$3 a month could make a big difference.
- Alderman Speedy leaned toward Option A because neither option comes close to recovery of cost of service.
- · Alderman Petersen: A \$3 increase in water over the current rate would be over 25%. Difficult for persons on fixed incomes or who do not use much water.

Motion to approve Ordinance 2018-47, Option B, carried 6-1 with Alderman Speedy voting no on First of Three Readings.
