Discussion:

- Many of the water and sewer lines being replaced or repaired are 40 to 70 years old.
- Advanced Water Metering will be done in four phases. Meters will be replaced to allow reading the meters remotely and since it is being seen in real time leaks can be detected right away.
- On several projects, the work is being done internally.
- These projects are more system driven and some are rate structured.
- Alderman Burger asked for a list of projects already underway, and asked which ones are for health and safety reasons if close to medical buildings.
- Work Orders are submitted for work to be done under the annual on-call contracts.
- Brief discussion on prioritizing these projects. Most are for aging infrastructure. This category is more difficult to rate. The aldermen were asked to give feedback and may rank less than ten projects.
