- Jordan Branch bid twice. Unable to get bidders because of constraints involved with the project. The banks are extremely eroded. Roots exposed on majority of trees and they are unstable. Homeowners may need to dedicate easements.
- Maplewood project runs between houses. Corrugated metal pipe bottoms missing. Will line the pipes. Almost ready to bid.
- Carlisle HOA project: water getting in crawl space and in garage. Garage built lower than the street.
 Waiting on funding for design. Tree line between Carlisle and Founder's Pointe may have to be removed.
- West Main Bridge widening. Ready to move to design when funding allocated. Would take about a year for relocation of utilities.
- 100 Battle Avenue: Multiple options looked at. Staff recommends buyout of the two homes and then
 pursue a detention pond.
- Kristen Ridler, 109 Battle Avenue: They have been in limbo for over a year about what the City plans to do. Now they need a new roof and don't want to invest in that if the house is to be razed. When they purchased the house, they weren't told about the flooding and how many times it had flooded. No water gets in the basement, but the yard gets flooded.
- Buddy Mills, 111 Battle Avenue: A longtime resident. 100 block is a local flooding problem with pooling of water. A buyout would be the best solution with a holding pond. He would like a decision as well.
- The homes were appraised at \$600,000 and \$400,000. Both homes have basements. The best and less costly solution is the buyout.
- The Home Raising Project total is up from 20+ houses to 35 homes for an estimated total of \$4 M with the City paying \$1.4 M of that total. It is unknown at this time how many residents would agree to pay a percentage of the elevation. The range in elevation goes as high as 11 ft.
- Ralston Creek: The banks must be restored. One property has lost most of the backyard and the bank erodes every time it rains.
- Parkview: Margin Street has no Stormwater infrastructure. Evans Street has always flooded, even before houses were built there.

- Municipal Complex project underway. Asphalt damaged. Replace with heavy duty concrete, improvements to Stormwater drainage, need to connect waterline from Century Court. Some of 2017 bond issue money will be used.
- A City-owned parking lot on 5th Avenue, just past French's Boots, could be paved and used for parking and could accommodate tour buses.
- Work with architect regarding a new City Hall. Input will be sought from department heads and will
 find out needs from current staff. There are implications for the entire City block. City Hall will go
 vertical with additional parking. Private development will offset the cost and benefit the community.
- Alderman Barnhill: Will not support City Hall taking up the entire 4-acres of unique and valuable land. It is an opportunity to offset the \$24 M cost.
- Vice Mayor Martin wants the City to retain the property.
- Alderman Burger brought up the high cost of maintaining the current, aging City Hall, and that it will keep escalating.
- A new parking structure would cost approximately \$8 million. Could be a surface lot first. Consideration of public/private partnership.
- Alderman Speedy mentioned festival parking and the shuttles that bring people from Church of the City and Harlinsdale downtown.

Mr. Stuckey asked the Board to prioritize just five top Stormwater projects. At the November 27th Work Session, the dollar amounts will be presented. The Board will then work toward a decision in early 2019.

Project Preferences:

- Vice Mayor Martin: Promoting the Battle Avenue Project even though it is not in her ward. The
 residents have been waiting a long time are now in limbo not knowing if their homes will be razed.
 Her #1 priority is the widening of the bridge on Main Street, so the residents can get from one part
 of town to other safely. Evans Street can wait because they knew about the flooding when they built
 homes there. With any leftover money they could talk about elevating the 35 homes.
- Alderman Petersen: Strongly recommends the opportunity to use FEMA money to elevate the 35 homes. Since this is a voluntary program, she wondered how many would participate knowing they must pay 35% of the cost themselves.
- Alderman Speedy: Battle Avenue is a priority since the owners are in limbo. The storage facility and
 the veterinarian facility added to the area made the problem worse. The FEMA project would be a
 tough decision for him because it is voluntary. Some couldn't afford to do it without a low interest
 loan.
- Jordan Branch and Ralston Creek should be considered as well.
