# The Program

The Midnight Sun Scavenger Hunt was created by the Williamson County Convention & Visitors Bureau (WCCVB) to:

- Encourage visitors and residents to explore the city of Franklin.
- Expand downtown Franklin's public art offering.
- Enhance the visitor experience by offering a fun family-friendly activity that is both visually pleasing and educational.



# The Artwork



In honor of Midnight Sun and the rich walking horse history in Franklin the WCCVB proposes the installation of 10 miniature bronze horse statues at different historical locations throughout historic downtown Franklin.

Statue Details and Dimensions

Bronze with granite base

Dimensions (L x W x H)

6" x 2.75" x 9.5"

The WCCVB will oversee the installation of 10 permanent bronze horse statues at the following historical locations throughout historic downtown Franklin. These locations have been approved by the property owners.

- Home of Sallie Ewing Sims Carter Gaut (currently Shuff's Music)
- Harlinsdale Farm (approved by City of Franklin Parks Dept.)

# The Artist

The WCCVB has partnered with local sculptor and artist Janel Maher who will be making all of the horse statues. The decision was made to cast these horse statues in bronze with granite bases because of the durability of these materials as they have proven to withstand all types of weather.



# Janel Maher

Janel Maher's sculptures are known for capturing the heart, soul and very essence of one of our greatest treasures - the horse. Janel's bronzes can be found among collectors throughout the United States, Europe and South America with two perpetual trophies in England and South Africa.

Janel's passion for capturing an individual horse's character and conformation is evident in her commissioned pieces that range from sculptures of National Champions to the monument at Thoroughbred Motor Cars. Martin Bennett, President of Thoroughbred Motor Cars, says "Janel managed to absorb the philosophy which drives our company and express it through her marvelous interpretation of the horse on our logo."

Growing up in Colorado, Janel Maher dreamed of horses in her youth. "My early drawing and painting set the stage for my wish to become an artist. I was always fascinated with animals, horses in particular. Many of my paintings or sculptures are inspired by my own horses, poetry, a song, or sometimes just a comment I've heard. It is always my goal for the viewer to see a subject that breathes life."

Janel was the winner of the prestigious Marilyn Newmark Memorial Award for realism at the 2013 American Women Artists 25th Annual Juried Art Show for the bronze "Cheval" She also was awarded the Presidents Award at the Women Artists of the West 45th Annual Juried Art Show for the bronze "Galileo" This was the first time that this award was presented to a sculptor.

In describing the bronze "Ponies Before the Storm," one collector says, "Horses run through Janel Maher's hands...and she stops them in bronze so we can touch them."



# Past Project/Awards



Janel's Bronze Galileo won the President's Award at the 45th Annual National Exhibition of the Women Artists of the West, the first time it was awarded to a sculptor.



# Installation and Maintenance

Installation at each privately-owned location will be the responsibility of the WCCVB.

The City of Franklin Parks Department will oversee installation at Harlinsdale Farm.

The bronze statues will be drilled into cement or wood at each site with bolts readily attached to the granite bases.

The WCCVB will take full responsibility of maintaining each bronze horse statue.



# The Funds

This project has a projected budget of \$10,000 which includes the cost of each horse, installation, brochure creation and printing and buttons. The WCCVB is seeking strategic partnerships within the community to help sponsor the creation and installation of each of the 10 horse statues. At this time we have raised the needed funds through local sponsors.
