Animal Control Fee – Fiscal Year 2019-2020

Dear Ms. Tallent:

As you may recall, the City of Franklin and Williamson County executed an interlocal agreement for the provision of animal control services. The agreement automatically renews for an additional year unless either party provides 90 days' notice to the other party. In addition, the agreement provides that Williamson County shall recalculate the fee each year based on the costs for the operation portion of the current total fiscal year animal control budget and provide the new fee prior to March 1 of the current year. The recalculation cannot exceed an increase of five percent (5%) from the previous year fee except in years in which a special census was completed.

Based on my calculations, the City of Franklin's contribution for fiscal year 2019-20 is \$118,674.00. Please sign this letter acknowledging your receipt and return it to my attention. You may e-mail it to Nena.Graham@williamsoncounty-tn.gov. The payment for animal control services is due any time between July 1, 2019 and June 30, 2020.

Most All cities have had a special census, those figures were used for this year's contribution.

The operating portion of the budget is approximately 25 % of the total budget. Per our agreement, Cities would contribute 25% of the total budget allocated by the percentage of population from the last federal census or special census. The increases would be automatic based on the county budget guidelines. For Fiscal year 2018-19, Employees received a 2% pay increase. Based on the agreement, Cities contribution can not exceed 5% in a year unless based on a change in population. Based on population changes again this year, the 2019-2020 budgeted figures will exceed the 5% contribution from the previous year.
