Dear Ms. Tallent:

I would like to request \$64,200 from the City of Franklin to purchase print books, audio, and digital formats for the Williamson County Public Library. Unlike the Williamson County funds, which provide for staffing and operating costs, the City of Franklin's contribution is used exclusively for reading materials.

Unknown by some individuals, one bestselling eBook costs us approximately \$84.00. The \$15.00 that individuals pay for that title is not available for libraries. This is due to agreements between book publishers and online distributors, which raise charges to libraries. The Library will use the City of Franklin funds to enhance our book collection and provide more reading materials for Franklin residents.

The residents of Franklin enjoy the resources of the Williamson County Public Library. The main library is an information gathering learning center from which citizens of all ages can take advantage and grow.

The generous partnership between the Williamson County Public Library and the City of Franklin continues to grow. Last April, the Williamson County Public Library Foundation sponsored an art show for Franklin Special School District Students. It was an amazing event and the Foundation plans on doing it again this spring.

Please consider this request as it benefits the majority of the City's taxpayers.
