A RESOLUTION TO AWARD THE CONSTRUCTION CONTRACT (COF CONTRACT NO. 2019-0093) FOR THE HENPECK LANE INTERCEPTOR SEWER PROJECT TO CIVIL CONSTRUCTORS IN THE AMOUNT OF \$2,953,238.00 AND TO ESTABLISH A PROJECT CONTINGENCY IN THE AMOUNT OF \$250,000.00

WHEREAS, on June 13, 2017, the City of Franklin Board of Mayor and Aldermen ("BOMA") approved Resolution 2017-46, A Resolution Authorizing the City of Franklin to Enter an Agreement with Williamson County Schools to Share the Cost of Extending Sanitary Sewer Service to Both the Oakview Elementary School and the Future Middle School on Henpeck Lane; and

WHEREAS, on April 26, 2019, sealed bids for the construction of the Henpeck Lane Interceptor Sewer Project (COF Project No. 2019-0093) were received by the City of Franklin Engineering Department at City Hall, 109 3rd Avenue South, Franklin, Tennessee, 37064 and were publicly opened and read aloud; and

WHEREAS, after careful review and tabulation of all submitted bids, City staff recommends award of the contract for construction of the Henpeck Lane Interceptor Sewer Project (COF Project No. 2019-0093) to the low bidder, Civil Constructors, in the bid amount of \$2,953,238.00; and

WHEREAS, in the case of any unforeseen or changed project conditions, quantities, or cost overruns, City staff requests an additional \$250,000.00 project contingency to allow for the expedient completion of the Henpeck Lane Interceptor Sewer Project (COF Project No. 2019-0093).

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF MAYOR AND ALDERMEN OF THE CITY OF FRANKLIN, TENNESSEE, AS FOLLOWS:

SECTION I. Approval is granted to award the contract for the construction of the Henpeck Lane Interceptor Sewer Project (COF Project No. 2019-0093) to Civil Constructors in the amount of \$2,953,238.00.

SECTION II. Approval is granted to create a project contingency in the amount of \$250,000.00 for the Henpeck Lane Interceptor Sewer Project (COF Project No. 2019-0093).

SECTION III. Authority is granted to the City Administrator and Water Management Director to review and approve the spending of all project funds, both in the bid award and from the project contingency, toward the completion of the Henpeck Lane Interceptor Sewer Project (COF Project No. 2019-0093).
