





The City will install the Franklin Road sidewalk at the project site at an unknown future date, as part of the City's Franklin Road Streetscape project. Therefore, the applicant shall provide a cash contribution of \$69,825 in the form of a cashier's check payable to City of Franklin, to be utilized by the City to install the aforementioned Franklin Road sidewalk onsite by the City at an unknown future date. By submitting the aforementioned cash contribution, the applicant acknowledges and agrees that there is no expectation of reimbursement of any of the funds stipulated in this condition of approval, nor any expectation of any payment for interest. Applicant shall submit the cashier's check, payable to City of Franklin, to the attention of the Planning and Sustainability Department.
