RE: Benelli Park HOA (Franklin, TN)

Dear Mr. Moser:

I represent the above HOA as it relates to a new ordinance prohibiting parking on both sides of the road leading into Benelli Park Court. The roadway leading into Benelli Park Court is only 22 feet wide and a fire engine or other large vehicle would not be able to get into our neighborhood with vehicles parked at the entrance. There are vehicles parked close to the entrance almost every day. They are using our street as a parking lot.

I spoke with you about submission of a plan to the City of Franklin for parking on our street. I have attached a petition (as you suggested) wherein all families on our street have agreed that no parking signs should be placed on both sides of the road next to the entrance. If the City approves a no parking sign on only one side of the street, people will still park on the other side which prohibits large vehicles currently from entering our neighborhood and also makes it difficult for all of us to get into and out of the neighborhood.

We want to be good neighbors to all but both of these signs are necessary because the free parking on our street is not going to stop until the signs go up. Please let me know what else you need from us to make this decision.
