### A RESOLUTION TO REVISE THE ORGANIZATIONAL CHART WITHIN THE CITY COURT DEPARTMENT

**WHEREAS,** the Board of Mayor and Aldermen established the annual budget for the City of Franklin for the Fiscal Year 2019-2020 by Ordinance 2019-17, effective July 1, 2019; and

**WHEREAS,** the Revenue and Licensing Manager/City Court Clerk desires to adjust the Organizational Chart of the City Court Department; and

**WHEREAS,** with respect to the City Court the reorganization will provide for greater efficiency and improved management of qualified staff to perform the vital functions of the City Court; and

**WHEREAS,** the Board of Mayor and Aldermen desires to support the minor reorganizations of the City Court to include this initiative as there would be no increase in anticipated costs for FY 2020; and

**WHEREAS,** the Board of Mayor and Aldermen believes it is in the best interest of the City of Franklin to adopt such change.

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Mayor and Aldermen for the City of Franklin as follows:

**Section 1.** The City of Franklin hereby adopts the amended Organization and Personnel Charts for the Revenue Management Department, to be incorporated within the FY 2019-20 Budget, as shown in Exhibit A, attached, with the elimination of one (1) existing Deputy Court Clerk position and the addition of one (1) new Deputy Court Clerk/Cashier position, without amending the expenditures currently adopted in the FY 2019-20 Budget.

Section 2. That the Resolution shall be effective upon adoption.




