ORDINANCE 2019-44

AN ORDINANCE TO ESTABLISH A 2-HOUR PARKING TIME LIMIT ON BOTH SIDES OF 2^{ND} AVE NORTH FROM MAIN STREET TO BRIDGE STREET IN THE CITY OF FRANKLIN, TENNESSEE

WHEREAS, on July 10, 2018, the Board of Mayor and Aldermen approved Ordinance 2018-27, "An Ordinance to Implement Time Restricted Parking Within the Core Commercial / Retail Historic Downtown Area"; and

WHEREAS, Ordinance 2018-27 established 2-hour parking on 2nd Avenue North between East Main Street and the Alley; and

WHEREAS, redevelopment along 2nd Avenue North continues to attract the need for high-turnover parking in the core commercial/retail historic downtown area; and

WHEREAS, the business and property owners along 2nd Avenue North between East Main Street and Bridge Street have requested 2-hour time restricted parking along the street for visitor and customers; and

WHEREAS, on October 18, 2019, City staff received a petition to time restrict parking along both sides of 2nd Avenue North between East Main Street and Bridge Street; and

WHEREAS, out of 11 properties along this section of 2nd Avenue North, 9 property owners signed a petition to establish 2-hour parking along both sides of 2nd Avenue North between East Main Street and Bridge Street.

NOW, THEREFORE:

SECTION I: BE IT ORDAINED by the Board of Mayor and Aldermen of the City of Franklin, Tennessee, to establish 2-hour Parking along both sides of 2nd Avenue North between East Main Street and Bridge Street. The parking time restrictions shall be strictly enforced Monday-Friday between 8AM-5PM, excluding all City observed holidays.

SECTION II: BE IT FURTHER ORDAINED by the Board of Mayor and Aldermen of the City of Franklin, Tennessee, that the Streets Department Director, or their Designee, is hereby authorized to obtain and install all necessary signs and pavement markings within the downtown area to ensure these regulations are signed appropriately and remain enforceable.

SECTION III: BE IT FURTHER ORDAINED by the Board of Mayor and Aldermen of the City of Franklin, Tennessee, that the penalty for failure to obey the provisions of this Ordinance shall be as indicated in the Franklin Municipal Code and/or the Tennessee Code Annotated.

SECTION IV: BE IT FINALLY ORDAINED by the Board of Mayor and Aldermen of the City of Franklin, Tennessee, that this Ordinance shall take effect from and after its passage on second and final reading, the health, safety and welfare of the citizens of Franklin requiring it.
