Resolution 2016-40/Ordinance 2016-27 is the document required to annex the 204.081 acres of property on the Franklin City Limits. The property is adjacent to the current City of Franklin Municipal limits and within the City's established Urban Growth Boundary (UGB). A development plan and rezoning accompany this Resolution/Ordinance.
