(Deferred from 10-27-16 Capital Investment Committee)

<u>Purpose</u>

The purpose of this memorandum is to provide information to the Franklin Board of Mayor and Aldermen (BOMA) concerning Resolution 2016-72, which awards the Construction Contract (COF Contract No. 2015-0070) for the Goose Creek Sanitary Sewer Extension Project, from west of I-65 to the east side of I-65, to Dynamic Construction, LLC in the amount of \$1,717,620.40.

Background

On September 23, 2016, the City of Franklin Engineering Department received and opened bids for the Goose

Creek Sanitary Sewer Extension Project, from west of I-65 to the east side of I-65. The low bidder was Dynamic Construction, LLC, and they have provided adequate experience for a project of this magnitude. A recommendation letter from Hethcoat and Davis, including a bid tabulation summary, has been included for review.

Financial Impact

Below is the financial impact, based on the Amendment No. 1 to the Agreement from Goose Creek Sanitary Sewer Extension from West of I-65 to East of I-65 (COF Contract No. 2014-0051) approved by the BOMA on January 13th, 2015:

\$1,717,620.40	Total Construction/Bid Cost
<u>\$ 510,121.60</u>	HPT TA Properties Anticipated Reimbursement
\$1,207,498.80	COF Anticipated Cost (Sewer Operating Funds)

The City is also pursuing a reimbursement in the amount of \$152,120.98 for the design engineering, permitting, construction management, inspection and easement acquisition from HPT TA Properties. The actual amounts will be reconciled at the end of the project between the City and HPT TA Trust.

Recommendation

Staff recommends approval of Resolution 2016-72, awarding COF Contract No. 2015-0070 to Dynamic Construction, LLC in the amount of \$1,717,620.40.
