Purpose

The purpose of this memorandum is to provide information to the Franklin Board of Mayor and Aldermen (BOMA) concerning a request for sanitary sewer availability for the above referenced property.

Background

Domestic Water Meter Size(s): N/A (Mallory Valley Utility District)

This property is located outside of the City limits and is an acceptable distance to the City's Sewer mains.

A timeline of this availability requests is summarized below:

- August 29, 2018 availability application received for 999 Scramblers Knob
- October 24, 2018 availability application received for 1205 Scramblers Knob
- CIC October 25, 2018
 - Deferred to November for further research by WMD
- CIC November 29, 2018
 - o Referred to Work Session for discussion
- Work Session January 8, 2019

As requested, the WMD has prepared cost estimates for connecting this residence to the public sanitary sewer at an approximate cost to the Owner of \$3,000.

While this is an atypical method of expanding the collection system, availability can be provided to this residence at minimal cost. The WMD requests that the availability of 999 Scramblers Knob be contingent upon the resident entering into an agreement with conditions outlined in the attached Resolution. These conditions include:

- Property owner expresses a desire to annex into the City when the City deems it appropriate.
- Property owner agrees to participate in any future special assessment district within the Deerfield Subdivision.
- Property owner is responsible for all costs to connect to the public sanitary sewer system
- The conditions of the agreement shall be recorded at the Williamson County Register of Deeds.

Financial Impact

The recommended agreement will allow for a full cost recapture of the City of Franklin Water Management Department installation costs.

Recommendation

Staff recommends approval of this Resolution to provide sanitary sewer service to 999 Scramblers Knob, contingent upon the Property Owner entering into the agreement with the City outlined in the attached Resolution.
