Purpose

The purpose of this memorandum is to provide information to the Franklin Board of Mayor and Aldermen (BOMA) concerning a professional services agreement (PSA) with Barge Design Solutions for the Southeast Municipal Complex Master Planning.

Background

The 2015 Comprehensive Parks & Recreation Master Plan recommended the development of a new Southeast Multi-Purpose Park. The master plan made the following recommendation:

“The park should include a minimum of 8 lighted multi-purpose rectangular sports fields that could be

used for football, lacrosse, rugby and soccer. The Franklin Cowboys football program would move from Jim Warren Park to this new park when completed. This park should have a range of passive uses as well to serve as a Community Park for neighborhoods in this area. A master plan should be developed for the park once the site is identified to guide phased development of the park.”

On October 25th, 2016, the BOMA approved Resolution 2016-69, “A Resolution to Adopt the Project List for Phase I of the FY 2017-2026 CIP. This resolution included \$13,200,000 for the development of a Southeast Multipurpose Park. Below is a summary of the proposed scope of service:

On June 13, 2017 the Board approved a professional services agreement with Barge Design Solutions to develop a master plan for the Southeast Municipal Complex in the amount of **\$396,046.00** for the Southeast Municipal Complex Master Planning

On March 27, 2018, the BOMA approved Resolution 2018-15, “A Resolution Adopting the Southeast Municipal Complex Master Plan”. The purpose of this master plan was to define expectations for the use and general layout of the park and to assist in the planning and decision-making process regarding capital investments.

The proposed scope of services generally includes the design of the entrance roadway, coordination with utilities, synthetic turf multi-use sports fields, multi-use trail, grading, drainage, building design (concession, restroom and maintenance facility), required perming, field exploration and laboratory testing, PUD and Site Plan submittal packages and coordination with our bridge and roadway consultant. The latest construction estimate, as provided by Barge Design Solutions, is \$19.2 million.

Financial Impact

This PSA is for the lump sum amount of \$998,000. Funding for the project will be paid out of the FY2017-2026 CIP budget as allocated through resolution 2016-69.

Recommendation

Staff recommends approval of the professional services agreement (COF Contract No. 2019-0139) with Barge Design Solutions for the Southeast Municipal Complex Master Planning.
