Purpose

The purpose of this memorandum is to provide information to the Franklin Board of Mayor and Aldermen (BOMA) concerning the final reimbursement and close-out of the Recovery Agreement for Off-site Sanitary Sewer and Water Improvements for Battle Ground Academy (BGA).

Background

The intent of this resolution is to close out the Recovery Agreement for Off-site Sewer and Water Improvements and reimburse BGA for sewer access fees of \$52,500 collected for the last 25 lots in The Preserve at Echo Estates Section 2 based on the following:

• BOMA Minutes (2/14/1995) showing approval granting BGA the right of recovery of construction costs

incurred for the proposed sanitary sewer extension.

- BOMA Minutes (12/14/2004) approving the Recovery Agreement for Off-site Sewer and Water Improvements document.
- The Water Management Department has determined the drainage area that is served by the BGA sanitary sewer extension.
- The Director of Engineering has agreed that all of the construction is complete, and that reimbursement is appropriate.
- The Surety Coordinator has confirmed that no sureties are outstanding.
- Receipts support the construction amount in the agreement.
- Confirmation of Sewer Access Fees <u>collected</u> since the approval date of the document are equal to \$152,477.00.
- Confirmation of Sewer Access Fees <u>reimbursed</u> to BGA since the approval date of the document are equal to \$99,977.00.

Financial Impact

The City of Franklin agreed to reimburse BGA up to \$260,000 in Sewer Access Fees collected from lots in the drainage area that the sanitary sewer extension serves. To date, the City of Franklin has collected Sewer Access Fees of \$152,477.00, and has reimbursed BGA Sewer Access Fees of \$99,977.00, which leaves a remaining balance to be reimbursed to BGA of \$52,500 and will fully satisfy the terms of this agreement.

Recommendation

Staff recommends approval of Resolution 2019-83, Validating the Amount to Close-Out the Recovery of Offsite Sanitary Sewer and Water Improvements for Battle Ground Academy and Authorizing the Final Reimbursement of \$ 52,500.
