Consideration Of Resolution No. 2019-128, A Resolution To Award The Term Contract For The Sewer Lateral Rehabilitation For Areas Of The City Of Franklin Sewer Collection System To BLD Services, LLC In The Total Estimated Annual Amount Of \$452,500 For The Specified Estimated Annual Quantities For A Term Of Award Of One (1) Year, With Up To Four (4) One-Year Options To Extend, For The Wastewater-General Division Of The Water Management Department (Purchasing Office Procurement Solicitation No. 2020-002; \$100,000.00 Budgeted In 431-89320-52219 For Fiscal Year 2020; Contract No. 2018-0226) (WS 11/12/19)

Purpose

The purpose of this procurement is to purchase sewer lateral rehabilitation services for a term of award of one (1) year, with up to four (4) one-year options to extend, for the Wastewater-General Division of the Water Management Department. The term contract would be used to improve priority sewer laterals as identified by the City on the City's wastewater collection system.

Background

The City published on May 30, 2019 a Notice to Bidders in the *Williamson Herald* for sewer lateral rehabilitation term contract. In addition, bid documents were sent on or about the same date directly to three (3) potential bidders known or thought to be interested in this solicitation. Bids from three (3) service providers were publicly opened at the bid opening held on July 9, 2019. Both a tabulation of the bids received for this solicitation and a tabulation of bid line-item pricing are attached.

Financial Impact

The apparent lowest, most responsive and responsible bid, from BLD Services, LLC of Kenner, Louisiana, is in the total estimated annual amount of \$452,500 for the specified estimated annual quantities of the specified sewer lateral rehabilitation services for a term of award of one (1) year, with up to four (4) one-year options to extend. This bid was identified because it is the lowest bid that meets or exceeds the City's intention as expressed and implied by the City's specifications as well as the instructions, terms and conditions pertaining to this procurement solicitation. The Water Management Department Wastewater-General Division budget for

fiscal year 2020 allocates \$100,000 out of the Wastewater Fund for sewer lateral rehabilitation services.

Options

In accordance with the bid documents, the City reserves the right to reject any and all bids.

Recommendation

Staff recommends that the Board of Mayor and Aldermen approve Resolution No. 2019-128, a resolution to award the term contract for the sewer lateral rehabilitation for areas of the City of Franklin sewer collection system to BLD Services, LLC in the total estimated annual amount of \$452,500 for the specified estimated annual quantities for a term of award of one (1) year, with up to four (4) one-year options to extend. The City's Purchasing Manager believes the prepared solicitation documents as distributed allowed for competition among multiple service providers, and that the staff recommendation appears to be made in a fair and impartial manner based upon the proposals received. Pursuant to authority previously granted by the Board of Mayor and Aldermen, Contract No. 2018-0226 has been prepared for execution by the City Administrator and is attached pending approval by the Board of Mayor and Aldermen of the staff recommendation to approve Resolution No. 2019-128.
